

Update from U.S. Sen. John Cornyn January 2006

In the coming year, the second session of the 109th Congress, the Senate will address many issues of profound importance to the American people, among them bolstering border security and reforming our broken immigration system, reauthorizing the Patriot Act, a key tool in fighting terrorists, following the recent temporary extension, and continuing to see that our country has the resources it needs to continue to fight and win the war on terror. In all of these issues, you have my assurance that I will continue working hard for my fellow Texans.

Texas Wildfire Relief Efforts

In response to the recent wildfires that have burned hundreds of thousands of acres across Texas, the President earlier this month granted Texas a disaster declaration that will bring much-needed relief to the most affected counties in our state. Our work with FEMA and other federal officials is ongoing; we will do all we can to ensure we continue to overcome bureaucratic roadblocks in order to provide much-needed assistance in a timely manner. The President also appointed a Federal Coordinating Officer to help prevent unnecessary delay in the relief efforts, which should further streamline the process.

The Major Disaster Declaration will allow FEMA to provide two kinds of assistance to Texas. All 254 counties will be eligible to receive Public Assistance for emergency protective measures taken by local governments in response to wildfires that pose a significant threat to life and property. Additionally, select counties are eligible for Individual Assistance, which will help compensate home owners and business owners in those counties who suffered losses from these fires. Additional assistance may be approved as events warrant, and we will continue to inform Texans of any relevant developments. More information may be accessed online here.

Texas/U.S. Jobs and the Economy

Texas and the nation continue to see strong economic growth as the good news about the economy keeps coming, with the national unemployment rate slipping to 4.9 percent and unemployment claims at the lowest level in the last five years. According to recent figures from the U.S. Treasury Department, since the President signed the *Jobs and Growth Act* in May of 2003, Texas has added 317,000 jobs; 17,300 jobs were created in November of 2005 in our state and, at 5.2 percent, the unemployment rate for Texas is one of the lowest in modern history; and from the second to third quarters of 2005, personal income in Texas

rose 1.2 percent. In early January, I discussed this strong economic growth at the UPS facility in Austin, as well as during a visit with the Greater Dallas Chamber of Commerce.

According to labor statistics, two million new jobs were created in the United States in 2005. As long as we continue to keep taxes low and limit the regulatory burden on entrepreneurs and small businesses, they'll continue to create jobs and opportunities and ultimately prosperity for the people of Texas and across America.

Texas Travel

During the past month I had the opportunity to travel throughout Texas, and I look forward to several trips home in the coming weeks.

In Mission I met with elected officials and community leaders to discuss the issues necessary to ensure the success of the Lower Rio Grande Flood Control Project Levee Rehabilitation, and I will continue to work with South Texas leaders, the International Boundary and Water Commission, and my colleagues in the Senate to adequately address the needs of this levee project.

Additionally, I had the opportunity to meet with a wide variety of civic groups, community leaders, and elected officials in Victoria, Nacogdoches, and Austin to discuss the issues of immigration, health care, the judicial nominations process, ongoing hurricane relief efforts, the remarkably positive outlook for jobs and the economy, and the recent elections in Iraq. In Nacogdoches, I also participated in a roundtable with members of the agriculture community to discuss the farm bill, energy issues, immigration, and permanent repeal of the death tax.

In San Antonio, I was pleased to announce the recently awarded \$958,453 Healthy Communities Access Program grant to Access to Care for the Uninsured, which will allow this group to develop a shared patient data base to integrate and coordinate health care for patients that will allow health care providers to more effectively exchange information and therefore improve the overall level of care for the uninsured.

Border Security and Travel

This month in Laredo, Secretary of Homeland Security Michael Chertoff announced the creation of new Border Enforcement and Security Task Forces, as part of the Department's Secure Border Initiative aimed at increasing control over our borders. These task forces will be nationally-integrated teams with federal, state, and local representation specifically directed at cross-border criminal activity a new border task force.

The Border Enforcement and Security Task Forces build on the Department's experiences fighting violent cross-border crime in Laredo during Operation Black Jack. Operation Black Jack has been a focused effort operated by Immigration and Customs Enforcement to coordinate Customs and Border Protection, Drug Enforcement Agency, Federal Bureau of Investigations, Bureau of Alcohol Tobacco and Firearms, U.S. Marshals Service, and other state and local law enforcement agencies, with significant support from the United States Attorney's Office and the District Attorney's Office.

Improving security along our borders is one of the top priorities facing our nation today, so this latest move by DHS is encouraging. As chairman of the Subcommittee on Immigration, Border Security and Citizenship, I will continue working with Secretary Chertoff and other federal officials to ensure that balance is maintained between increasing security and promoting legal commerce, trade and tourism. It's critical that our Texas communities along the border aren't negatively impacted by these new measures and I'll work to make sure that doesn't happen.
