Appropriations Policy Brief

H.R. 2744 — Agriculture Appropriations Act for FY 2006

Excluding Emergency Appropriations and Mandatory Offsets, the Committee Bill is:

- > \$9 million more than last year
- > \$3 million more than the request

Budget Compliance: According to CBO, the bill is within the 302(b) allocation of the Agriculture and Rural Development Appropriations Subcommittee and thus complies with the Budget Act. The bill relies on \$1.4 billion (see discussion below) in mandatory offsets to pay for higher discretionary spending. The rule governing consideration of the bill protects these offsets from being struck on the floor.

<u>Unauthorized Appropriations</u>: According to the Committee report, the bill appropriates \$148 million for unauthorized programs. The Rules of the House prohibit this practice, but the rule governing consideration of the bill waived this restriction.

Presidential Terminations and Reductions:

Overview:

- The President proposed a total of \$1.74 billion in terminations and reductions to programs within the Agriculture Appropriations Subcommittee's jurisdiction.
- ➤ The Committee terminated 3 of the 3 programs the President proposed to terminate and reduced funding for all but one of those proposed to be scaled back (one program was increased). As a result, the Committee achieves \$1.49 billion in savings, \$250 million less than the President requested with regard to these selected programs.

AMS Biotechnology Program: Eliminates \$4 million in funding for the Agricultural Marketing Service's (AMS) biotechnology program. Created in 2002 to develop AMS's capacity to test non-grain commodities for bio-engineered traits, the Administration found a lack of demand for the service in the private sector.

High Energy Cost Grants: Eliminates \$28 million in funding for the Rural Utility Service's High Energy Cost Grants program, as requested by the Administration. Established in 2001, this program provides grants to areas where the cost to deliver energy is significantly higher than the average (only Alaska, Hawaii, and few other areas qualify). The Administration found the program to be duplicative of other RUS programs.

NRCS Watershed and Flood Prevention Operations: Reduces funding for the National Resources Conservation Services (NRCS) Watershed and Flood Prevention Operations program from \$75 million to \$60 million. This program provides technical and financial assistance to communities to design and construct flood protection and water quality improvement projects in small communities. The Administration proposed to terminate this program because it funds many privately owned projects, which are not Federal responsibilities, and OMB determined that it is the least cost effective Federal flood damage reduction program.

Research and Extension Grant Earmarks: Increases funding for the National Review Initiative (NRI) by \$20 million from \$180 million to \$200 million. This grant program provides resources for various research activities, such as improving asparagus technology, developing alternative salmon products, etc. The Administration proposed to "terminate" \$180 million worth of such earmarks but requested that this funding be used to pay for an increase in the NRI. The Committee funded the NRI at \$50 million *less* than the request. **Note:** The figures above do not count this Administration proposal since the funds were meant to be redirected to the same type of federal activity at a higher level of funding.

Agriculture Research Service (ARS): Reduces ARS funding by \$67 million to \$1 billion for in-house research by federal scientists on agricultural issues, such as productivity and human nutrition. Much of this research is earmarked (pgs. 12-22). The Administration requested a larger reduction, \$106 million, in order to focus resources on higher priority projects.

Mandatory Reductions Providing Discretionary Offsets: Includes numerous changes to existing mandatory spending programs, newly authorized in the 2002 farm program, that generate savings for discretionary spending contained in the bill. The Committee adopted \$1.4 billion in such savings (slightly more than the President proposed).

These changes include the following reductions:

- \$200 million from the Environmental Quality Incentives Program (EQUIP)
- \$120 million from value-added grants to local communities for marketing assistance
- \$300 million from the Initiative for Future Agriculture Food Systems (competitive research grants)
- \$210 million in watershed improvement funding
- \$100 million from the Rural Strategic Investment Program (economic development funding)
- \$90 million from the Bioenergy Program (funds to agriculture producers of biodiesel and ethanol)
- \$50 million from the mandatory loan program to encourage the rollout of broadband access in rural areas.

- \$89 million from the Rural Business Investment Program (economic development) and
- \$40 million from rural firefighter assistance grants.

NRCS Conservation Operations: Reduces funding from \$831 million to \$794 million for the NRCS Conservation Operations account, which provides technical assistance to states and localities running conservation programs. The Administration proposed to reduce such funding further to \$768 million citing a large number of un-requested congressional earmarks.

NRCS Resource Conservation and Development Program: Maintains funding for the Resource Conservation and Development Program, which provides resources to local communities for economic development, at \$51 million. The Administration proposed to reduce funding for the program to \$26 million, saving \$25 million under a new proposal to phase out federal support for certain local planning areas continuing to receive funding after 20 years.

Water and Waste Disposal Grants and Loans: Increases funding for the Rural Community Advancement Program's water and waste disposal grants and loans from \$520 million to \$562 million (an increase of \$42 million). This program provides resources to rural communities with populations of less than 10,000 to develop and finance water and waste disposal systems. The Administration proposed reducing the program's funding to \$446 million, saving \$74 million, citing relatively low interest rates that are allowing communities to rely on loans instead of grants.

Items of Note:

Country of Origin Labeling: Prohibits the use of funds to implement the Country of Origin Labeling (COOL) on meat and meat products.

Outsoucing/A-76 Activities: Prohibits funds for Circular A-76 activities (governing the federal government's outsourcing policies) until the Secretary has submitted to the Committees on Appropriations of both Houses of Congress a report on the Department's contracting out policies, including agency budgets for contracting out.

Colorado Land Lease: Allows the Secretary to lease 40 acres of land to Colorado State University for its Shortgrass Steppe Biological Field Station.

Tobacco Research: Prohibits ARS funding from being used for research related to the production, processing, or marketing of tobacco or tobacco products.

Future User Fee Proposals: Prohibits funds to pay the salary of any employee who works on the President's FY07 budget submission if it assumes new revenues stemming from user fee proposals that have not been enacted prior to the submission (unless the submission also identifies which spending proposals should not be enacted in the absence of the new revenues).

Hunger Fellowship Program: Provides \$2.5 million for Bill Emerson and Mickey Leland Hunger Fellowships.

Designation of Communities as Rural: Designates the following cities, townships, and municipalities as "rural areas" or otherwise eligible for various federal grant and loan programs: Bridgeton (NJ), Kingston (NC), Portsmouth (OH), Bloomington (IL), Hidalgo (TX), Elgin (OK), Lone Grove (OK), and Vega Baja, Manati, Guayama, Fajardo, Humacao, and Naguabo (Puerto Rico).

Earmarks:

Included in the bill **TEXT**:

- \$10 million for Florida citrus and lime growers for tree replacement resulting from citrus canker. \$30 million was provided in FY05, but the Administration did not request this funding for either FY05 or FY06.
- \$1 million for the Indian Creek Watershed Flood Prevention Project, Kane County, IL
- \$50,000 for the Hickory Creek Special Drainage District, Bureau County, IL
- \$1 million for the Ohio Livestock Expo Center in Springfield, OH

Included in the Committee Report (not an exhaustive list):

- \$775,000 for research on the Asian longhorned beetle and Emerald Ash borer
- \$500,000 for research on varroa mites at Baton Rouge, LA
- \$3.3 million for bovine spongiform encephalopathy (BSE) research: \$1.8 million for Ames, IA; \$1 million for Pullman, WA; and \$500,000 for Albany, CA
- \$300,000 for the U.S. Horticultural Research Laboratory at Fort Pierce, FL
- \$75,000 for alternative crop research development in Beltsville, MD
- \$100,000 for corn rootworm research in Ames, IA
- \$100,000 for invasive aquatic weeds research in Ft. Lauderdale, FL
- \$1.4 million for research on dietary intake, nutrient content and obesity issues:
- \$256,000 for integrated fruit and vegetable research at the University of Georgia
- \$1.2 million wolf predation management
- \$152,000 for blueberry and cranberry research, ME
- \$453,000 for fish and shellfish technologies, VA
- \$580,000 for human nutrition, NY
- \$579,000 for the International Arid Lands Consortium, AZ
- \$265,000 for peach tree short life, SC
- \$1.2 million for the Rural Policies Institute (NE, IA, MO)
- \$6.4 million for wood utilization (OR, NC, MS, MN, ME, MI, ID, TN, AK, WV)
