# Policy Brief......FY 2005 Commerce, Justice, State Appropriations

#### **BY THE NUMBERS:**

The Committee bill is \$878 million or 2.2% above last year and \$240 million or 0.6% above the request. According to the Budget Committee, the bill complies with sections 302(f) and 311(a) of the Budget Act

#### **PROGRAM TERMINATIONS:**

- Community Oriented Policing Services (COPS) hiring and overtime program (FY04 funding of \$118.7 million)
- The Juvenile Justice Accountability Block Grant (FY04 funding of \$59.4 million)

### LANGUAGE OF NOTE:

- The bill provides a new \$72 million for payment to the Radiation Exposure Compensation Trust Fund (authorized under 42 USC 2210 note).
- The bill provides \$1.255 billion for state and local law enforcement assistance, combining the local law enforcement block grant and the Byrne Formula program. Of this amount \$80

- million is for Boys and Girls Clubs, \$15 million is for the National Institute of Justice, and \$5 million is for USA FREEDOM Corps, according to the committee report.
- The bill extends for FY05 a provision allowing the Attorney General to grant posthumous citizenship to people who died on September 11, 2001, that met certain criteria.
- The bill contains a provision detailing retention and relocation bonuses for FBI and retired FBI employees
- \$3 million is provided in the State Department budget "only for the operations of the Office on Right-Sizing the United States Government Overseas Presence."
- The Committee directs that no funds may be spent for processing export licenses for satellite components to the communist People's Republic of China.
- The committee indicates that of the IO funds, \$362.193 million will go to UN dues, an increase of \$21.4 million or 6.3%.
- The bill provides \$6 million "for the cost of a direct loan to the United Nations for the cost of renovating its headquarters in New York."
- Includes a provision increasing the amount of the rewards that can be offered for the capture of leaders of foreign terrorist organizations and includes a provision allowing for market research to determine the best means of communicating the reward.
- Includes a provision stating that none of the funds may be used by federal prisons to purchase cable television services, to rent or purchase audiovisual or electronic equipment used primarily for recreational purposes.
- Religious and Moral Protection: The bill continues prior-year language prohibiting any DOJ funds from being used to discriminate or denigrate moral or religious beliefs.
- Maintains Amendments Related to Gun Owners, gun records, and licensing that were offered by Rep. Tiahrt and included in last year's bill:
- Ban on Patenting Human Beings: Maintains Rep. Dave Weldon's prohibition on issuing patents directed to or encompassing a human organism.
- The committee creates a new Directorate of Intelligence at the FBI
- **Harold Rogers Prescription Drug Monitoring Program:** The committee includes \$10 million for this program which is \$3 million above the FY04 enacted level and \$10 million more than the request (this program was created in the FY02 CJS Appropriations bill.

**Recessions:** The bill rescinds \$20 million unobligated under state and local law enforcement assistance and \$61 million unobligated under COPS.

# **EARMARKS:**

The Committee Report directs the Office of Justice Programs to report to Congress on whether or not it will fund over 100 separate projects (See Pages 36 through 39 of the Committee Report).

The Committee Report directs the COPS program to report to Congress on whether or not it will fund 37 separate methamphetamine enforcement projects (See Pages 42 through 43 of the Committee Report).

The Committee Report directs the COPS program to report to Congress on whether or not it will fund 29 separate law enforcement projects (See Page 44 of the Committee Report) and specifies (on over a page) cities that COPS should look at for grants for technology improvements to police and sheriffs departments (See Pages 44-46 of the Committee Report).

The Committee Report directs the Office of Justice Programs to report to Congress on whether or not it will fund an over four-page long list of projects (See Pages 49 through 53 of the Committee Report).
