Appropriations Policy Brief

H.R. 2361 — Interior and Environment Appropriations Act for FY 2006

Excluding Emergency Appropriations, the Committee Bill is:

- > \$653 million (2.5%) less than last year
- > \$432 million (1.7%) more than the President requested

<u>Budget Compliance</u>: A CBO score is not yet available. However, if consistent with funding levels provided in the Committee report, the bill would be within the 302(b) allocation of the Interior and Environment Appropriations Subcommittee and thus complies with the Budget Act.

To fit within the budget resolution, the bill relies on a \$100 million rescission in budget authority from previously appropriated grants and contracts in EPA accounts. However, according to the Budget Committee, the outlays (meaning the money that will actually be spent by the agency) actually saved from this rescission are only \$5 million. In short, the \$100 million in extra spending is "offset" with only \$5 million in actual savings to the taxpayer. While the Appropriations Committee technically meets its allocation under the budget resolution with this offset, the practical effect to the taxpayer is an additional \$95 million in spending above the budget.

<u>Unauthorized Appropriations</u>: According to the Committee report, the bill appropriates \$6.14 billion for unauthorized programs. The Rules of the House prohibit this practice, but the rule governing consideration of the bill is expected to waive this restriction.

Presidential Terminations and Reductions:

Overview:

- ➤ The President proposed a total of \$1.97 billion in terminations and reductions to 15 programs within the Interior and Environment Appropriations Subcommittee's jurisdiction.
- The Committee terminated 3 of the 7 programs the President proposed to eliminate (and reduced funding for the other 4). 5 of the 8 programs proposed for reduction were cut (although only one to the extent called for by the President), and two were increased. As a result, the Committee achieves \$986 million in savings, \$988 million less than the President requested with regard to these selected programs.

National Heritage Area Grants: Increases National Heritage grants from \$14.6 million to \$15 million. The program assists local groups protect historical resources in 27 federally designated areas. According to the Administration, this funding was meant to be temporary, and only \$5 million was proposed for the program. On page 43 of the report, the Committee lists the program's earmarks.

Payment in Lieu of Taxes (PILT): Increases PILT payments by \$3.2 million from \$226.8 million to \$230 million. PILT payments go to counties that contain large shares of federally owned land to compensate for an inability to tax federal lands. The Administration proposed to decrease these payments by \$27 million to \$200 million for a number of reasons: (1) these counties currently share in the revenues generated from mineral and other extractive industries, (2) the federal government covers many of the costs associated with managing these lands, such as road maintenance, and (3) these payments were held at roughly a flat rate for two decades, until 2001 when they increased 48%.

Mineral Resources Program: Maintains funding for the U.S. Geological Survey's Mineral Resource Program, which provides information on the location and quantity of minerals and the impact of mining on the environment. The Administration proposed to reduce funding for the program by \$29 million because the informational products tend to be used by state, localities, and academia, instead of the federal government. This program is funded within a larger allocation for geologic resource assessments that receives a small increase, but it is not clear whether this increase is directed at the Mineral Resources Program.

Jobs-in-the-Woods Program: Eliminates funding for the Bureau of Land Management's program (\$6 million in FY05) to find employment for timber workers find employment who lost their jobs as a result litigation over the endangered Northern Spotted Owl. The Administration found that many of the workers had moved on to other jobs.

National Park Service Statutory Aid: Eliminates \$11 million worth of earmarks for conservation and historic preservation, including the Native Hawaiian culture and arts program, Alaska National parks, and the Benjamin Franklin Tercentenary Commission. See pages 40-41 of the Committee report for the complete list.

LWCF State Recreation Grants: Eliminates \$90 million in funding for the Land and Water Conservation Fund (LWCF) State recreation grant program as requested by the Administration. These grants have been used to improve state and local parks.

Rural Fire Assistance Program: Reduces from \$10 million to \$5 million the funding for Interior's Rural Fire Assistance Program, which provides assistance for communities under

10,000 to purchase fire engines and other firefighting equipment. The Administration proposed its termination finding it duplicative of other fire assistance grant programs.

Water Quality Cooperative Agreement Program: Reduces funding for the EPA's Water Quality Cooperative Agreement Program from \$17 million to \$15 million. The program provides grants to States and municipalities to prevent and eliminate water pollution, primarily through research, and investigations. The Administration proposed its termination.

School Construction Program: Reduces funding for the Bureau of Indian Affairs' School Construction program from \$263 million to \$226 million. The Administration proposed only \$174 million for the program, citing the BIA's inability to spend past funding increases (as evident from large unobligated balances) and the fact that new BIA schools are built far in excess of student enrollment needs.

EPA Unrequested Earmarks: Reduces funding for earmarked projects in three EPA accounts from \$468 billion to \$280 million. The Administration proposed to terminate these earmarks altogether. (The Administration's claim that these three accounts totaled \$489 billion in FY05 differs from the tables provided in the Committee report.)

Alaska Native Villages: Reduces funding for the EPA's Alaska Native Villages program from \$45 million to \$15 million, saving \$30 million as requested by the Administration. The program provides grants to the State of Alaska to help rural and native communities, who lack flush toilets and running water, improve their sanitation infrastructure. The Administration cited audits that the program has been prone to unexplainable purchases, cost overruns, and wasteful spending.

Clean Water State Revolving Fund: Reduces funding for the EPA's Clean Water State Revolving Fund from \$1.1 billion to \$850 million, saving \$241 million. The Administration proposed saving \$361 million by setting the funding level at \$730 million. The program provides matching funds to help States provide below-market loans to communities for wastewaster improvements.

Economic Action Program: Reduces from \$19 million to \$8 million the funding for the Forest Service's Economic Action Program, which provides technical assistance to forest-dependent rural communities,. The Administration proposed to terminate the program citing its duplication of other rural development programs.

Forest Service Capital Improvement and Maintenance: Reduces funding for Capital Improvement and Maintenance program from \$515 million to \$468 million. The program provides funds to improve and maintain roads and trails for the National Forest System. The Administration called for only \$381 million for the program and called for reforms (requiring subsequent legislation) to have Forest Service facilities pay a portion of these costs.

Wildland Fire Management: Reduces funding for the Forest Service's Wildland Fire Management program from \$2.1 billion to \$1.8 billion. The Administration proposed \$1.4 billion citing \$394 million in un-requested one-time supplemental funds. If FY05 emergency funds are excluded, the Committee increases fire suppression funding by \$117 million. According to the Committee report, the fire suppression funding level in the bill is \$45.6 million above the 10-year average of actual fire suppression expenditures.

Items of Note:

Capital Improvements to Fire Facilities: Allows the Secretary of the Interior to use wildland fire appropriations to enter into non-competitive sole source leases of property with local governments, at or below fair market value, to construct fire facilities, such as fire guard stations and retardant stations.

Wildland Fire Management Flexibility: Allows the Secretary of the Interior and the Secretary of Agriculture to transfer up to \$9 million between the two departments for wildland fire management programs and projects.

Donated Aircraft: Allows the Fish and Wildlife Service to accept donated aircraft as replacements for existing aircraft.

Save America's Treasures: Continues to fund at \$30 million the Save America's Treasures Program begun by former First Lady Hillary Clinton to help preserve nationally significant sites, structures, and artifacts.

Washington Monument Visitor Facility: Prohibits funds from being used for the planning, design, or construction of any underground security screening or visitor facility at the Washington Monument until the House and Senate Committees on Appropriations have approved such a facility in writing.

Biodiversity Convention: Prevents funds from being used for activities in direct response to the United Nations Biodiversity Convention.

Leasing Activities: Prohibits funds from being used for Outer Continental Shelf leasing activities in certain areas of California, the North Atlantic, Washington and Oregon, and the eastern Gulf of Mexico

Underground Lunchroom: Prohibits funds from being spent to close the underground lunchroom at the Carlsbad Caverns National Park.

Indian Gaming: Allows the National Indian Gaming Commission to collect \$12 million in fees for fiscal year 2006. In addition, the bill prohibits gaming under the Indian Gaming Regulatory Act on lands described in section 123 of the Department of the Interior and Related Agencies Appropriations Act, 2001, or land that is contiguous to that land.

Outsourcing/A-76 Activities: Limits the amount of funds (\$3.5 million) to initiate or continue outsourcing studies under OMB Circular A-76 (governing the federal government's outsourcing policies). In addition, the Forest Service is exempted from certain requirements under Circular A-76.
