MONDAY, MARCH 13, 2006

The House is in pro forma session at 2:00 p.m.

TUESDAY, MARCH 14, 2006

The House will meet at 12:30 p.m. for morning hour and 2:00 p.m. for legislative business. Votes will be postponed until 6:30 p.m.

Suspensions (11 bills):

- 1) **H.R. 4346** – Malcolm Melville `Mac' Lawrence Post Office Designation Act (*Rep. Buyer – Government Reform*)
- 2) **H.R. ____** – To amend the Harmonized Tariff Schedule of the United States to modify temporarily certain rates of duty, to make other technical amendments to the trade laws, and for other purposes (*Rep. Shaw – Ways and Means*)
- 3) **S. 1184** – A bill to waive the passport fees for a relative of a deceased member of the Armed Forces proceeding abroad to visit the grave of such member or to attend a funeral or memorial service for such member (*Sen. Biden – International Relations*)
- 4) **H.Con.Res. 190** – Expressing the sense of the Congress that the Russian Federation should fully protect the freedoms of all religious communities without distinction, whether registered and unregistered, as stipulated by the Russian Constitution and international standards (*Rep. Smith {NJ} – International Relations*)
- 5) **H.R. 4841** – To amend the Ojito Wilderness Act to make a technical correction (*Rep. Udall {NM} – Resources*)
- 6) **H.Con.Res. 350** – Permitting the use of the rotunda of the Capitol for a ceremony as part of the commemoration of the days of remembrance of victims of the Holocaust (*Rep. Cantor – House Administration*)
- 7) **H.R. 4826** – To extend through December 31, 2006, the authority of the Secretary of the Army to accept and expend funds contributed by non-Federal public entities to expedite the processing of permits (*Rep. Baird – Transportation and Infrastructure*)
- 8) **H.R. 4911** – Higher Education Extension Act of 2006 (*Rep. McKeon – Education and the Workforce*)
- 9) **S. 2363** – A bill to extend the educational flexibility program under section 4 of the Education Flexibility Partnership Act of 1999 (*Sen. Burr – Education and the Workforce*)
- 10) **H.Res. 698** – Expressing the sense of the House of Representatives that all Americans should participate in a moment of silence to reflect upon the service and sacrifice of members of the United States Armed Forces both at home and abroad (*Rep. Knollenberg – Armed Services*)
- 11) **H.Con.Res. 354** – Expressing the continued support of Congress for requiring an institution of higher education to provide military recruiters with access to the institution's campus and students at least equal in quality and scope to that which is provided to any other employer in order to be eligible for the receipt of certain Federal funds (*Rep. Pombo – Armed Services*)
