GOP FUNDING BILL SHORTCHANGES AMERICA'S CHILDREN

On September 9, House Republicans broke their promise to America's schoolchildren by passing a FY 2005 Labor/HHS/Education funding bill (H.R. 5006) that shortchanges the bipartisan No Child Left Behind Act (NCLB). While NCLB demands that all students make progress and every classroom have a highly qualified teacher, the Republican bill fails to provide the resources needed to make education reform a success. The result of prioritizing supersized tax cuts for millionaires ahead of children and their families, the Republican bill cuts NCLB funding for America's children by a total of \$9.5 billion below the levels promised by the Act, with key cuts highlighted below. In addition, the GOP bill failed to fully fund the Individuals with Disabilities Act (IDEA). In contrast, Democrats sought to fully fund NCLB in H.R. 4473, and to invest \$5.7 billion more in education by amending H.R. 5006; Republicans, however, blocked this education initiative.

GOP BILL SHORTCHANGES TITLE I

- **Underfunding The Cornerstone of The No Child Left Behind Act – Title I.** Title I is the primary federal program to help the nation's low-income students achieve to NCLB's rigorous academic standards. For FY 2005, NCLB authorizes \$20.5 billion – yet the GOP funding bill provides only \$13.3 billion. Under the GOP bill, 2.4 million children will lose \$7.2 billion in Title I grants below the amount promised by NCLB.

GOP DENIES AFTER-SCHOOL OPPORTUNITIES TO AMERICA'S CHILDREN
