Dear Senators Specter and Leahy,

I have received a letter from Senator Kennedy dated December 30, 2005, asking for additional information not requested in prior letters from members of the Senate Judiciary Committee, and covering a longer time frame than that covered by Senator Leahy's letter dated November 18, 2005. Question 5 asks me whether there were any communications regarding Judge Alito's Vanguard holdings or possible recusal in Case No. 01-1827 other than his letter to me dated December 10, 2003, and any items on the docket. To the best of my recollection, I spoke with Judge Alito on the telephone prior to his recusal and told him I did not believe it necessary for him to recuse. I have asked Marcia Waldron, the chief clerk of our Court, to respond to Senator Kennedy's other questions, and I enclose her response.

As you previously asked me and as I stated in my memorandum of December 13, 2005, Column Seven of Judge Alito's current recusal list indicates the Clerk's Office was informed that Vanguard should appear on his recusal list on December 10, 2003. To the best of my knowledge, we have no information that Vanguard appeared on Judge Alito's recusal list prior to that time.

I enclose the remainder of the non-public docket for Case 01-1827, which was printed on December 30, 2005. The docket we enclosed with the last letter stopped at December 31, 2003, because the Committee's letter asked about records of recusal checks only up to that date.

The docket does not record any "results" of the recusal check done on September 16, 2002, because there was no change from the prior check. Recusal notes are made only if a recusal check produces a new match.

The screen shots of Judge Alito's recusal list were printed in late November in response to your inquiries.

There are no earlier printouts of the non-public docket for Case 01-1827. Although the non-public docket is provided to the panel when the case is submitted for decision, it is not retained.

The docket dated October 31, 2005 shows all entries as they existed at the close of the case. The last entry was made on March 8, 2005. No edits were made after that date.
