Commodity Partnerships for Risk Management Education

U.S. Department of Agriculture (USDA), Federal Crop Insurance Corporation (FCIC)

The Federal Crop Insurance Corporation (FCIC), operating through the Risk Management Agency (RMA), announces the availability of approximately \$500,000 for Commodity Partnerships for Risk Management Education (the Commodity Partnerships program). Since the Agricultural Risk Protection Act of 2000 authorized the use of partnerships to provide risk management education, RMA has annually offered partnerships to provide education to producers of crops currently not insured under Federal crop insurance, specialty crops, and underserved commodities, including livestock and forage (priority commodities). Even though these partnerships have been very successful, there is a segment of producers that have not been reached with these education programs--refugees and low income individuals who produce, or who are undertaking to establish a business producing, priority commodities (target producers). The purpose of this cooperative partnership agreement program is to deliver risk management training and information to these producers. Recipients of awards must demonstrate non-financial benefits from a cooperative partnership agreement and must agree to the substantial.

The NEA International Literature Awards will provide American readers with greater access to the contemporary literature of Europe and increase the number and quality of foreign literary works that are published in the United States each year. This year the NEA International Literature Awards will

focus on Europe with partnerships between the Arts Endowment and the countries of Greece and Spain. All projects must involve the translation of literary works from Greece or Spain into English and the promotion of those works to American readers. Authors must be born after 1946 and the works must be previously unpublished in English. Reprints are not eligible. For the translation of works from Greece there is a special interest in short fiction and novels. Funding is available for all aspects of the process -- from translation to publication and distribution. Project expenses may include fees to translators, publication costs, and public outreach activities such as author/translator tours or educational programs.

Ensemble Theatre Travel Subsidy Program

Deadline: 09/12/2006

The Ensemble Theatre Travel Subsidy Program provides grants to theater directors, producers, presenters, managers, artists, and agents to see work by ensemble theater companies who have initiated a dialogue with them about a long-term partnership. In addition, artistic, production, education, publicity, or marketing staff at ensemble theater companies are eligible for funds to visit a potential host theater or arts presenter in order to effectively prepare for an engagement at least six to twelve months in advance.

Eligible Applicants: individuals at nonprofit 501(c)(3) theaters, presenting organizations, and artist management companies. Independent directors, producers, presenters, or artist managers without a nonprofit affiliation and staff at for-profit artist agencies and management firms are eligible if they meet the following criteria: the travel must have educational purposes that will assist the individual traveling in making more informed decisions in communicating about and/or managing an existing project or collaboration between an ensemble theater and a theater partner, or an arts presenter partner or consortia of theaters and arts presenters. Travel for the purpose of business development and developing artist rosters is ineligible.

Documenting Endangered Languages

National Science Foundation (NSF)

Deadline: 09/15/2006

This multi-year funding partnership between the National Science Foundation (NSF) and the National Endowment for the Humanities (NEH) supports projects to develop and advance knowledge concerning endangered human languages. Made urgent by the imminent death of an estimated half of the 6000-7000 currently used human languages, this effort aims also to exploit advances in information technology. Funding will support fieldwork and other activities relevant to recording, documenting, and archiving endangered languages, including the preparation of lexicons, grammars, text samples, and databases. Funding will be available in the form of one- to three-year project grants as well as fellowships for up to twelve months. At least half the available funding will be awarded to projects involving fieldwork.

Eligible Applicants: Academic institutions and non-profit, non-academic organizations located in the United States are eligible. For-profit organizations are not eligible to apply to this program.

Grants for Stabilizing Humanities Collections

National Endowment for the Humanities (NEH)

These grants help museums, libraries, archives, and historical organizations preserve their humanities collections through support for improved housing and storage, environmental conditions, security, lighting, and fire protection. Eligible activities include: 1) the purchase of storage furniture and the re-housing of humanities collections and materials that directly document the collections, such as field notes, site maps, or catalog records; 2) the improvement of environmental conditions under which collections are stored or exhibited (which may encompass the installation of climate control systems); and 3) the installation of security, lighting, and fire detection and suppression systems.

Challenge Grants #2

National Endowment for the Humanities (NEH)

NEH challenge grants help institutions and organizations secure long-term improvements in and support for their humanities programs and resources. Because of the matching requirements, these NEH awards also strengthen the humanities by encouraging nonfederal sources of support. Both federal and nonfederal funds must provide long-term benefits to the humanities. Challenge grant funds should not merely replace funds already being expended on the humanities, but instead should reflect careful strategic planning to strengthen and enhance the institution's activities in and commitment to the humanities. Direct grant funds may also be used for bridging support, where the challenge grant provides for endowment income to meet the same expenses in the future. Bridging funds up to the equivalent amount of projected endowment income may be used to cover expenses during the grant period, while the endowment is being established.

Maximum Grant Size: \$500,000

Eligible Applicants: With the exception of elementary and secondary schools or school districts, any U.S. nonprofit institution (public agency or private nonprofit organization) working wholly or in part with the humanities may apply for a challenge grant. Museums for America

Institute of Musuem and Library Services (IMLS)

Museums for America is the Institute's largest grant program for museums, providing more than \$17 million in grants to support the role of museums in American society to sustain cultural heritage; to support lifelong learning; and to be centers of community engagement. Museums for America grants strengthen a museum's ability to serve the public more effectively by supporting high-priority activities that advance the institution's mission and strate-gic goals. In FY 2007, Museums for America funding will support projects and activities, designed by the institution, that strengthen museums as active resources for lifelong learning and key players in the establishment of livable communities. Museums for America grants are designed to be flexible. They can be used for ongoing museum activities, research and other behind-the-scenes activities, planning activities, new programs or activities, purchase of equipment or services, or other activities that will support the efforts of museums to upgrade and integrate new technologies into their overall institutional effectiveness. A 1:1 match is required in each category. All applications must demonstrate evidence of institutional strategic planning and show the relationship between the activities for which funding is requested and the institution's plan. Although project activities may occur only once, project goals should be investments for the future, not one-time activities with no long-term impact on the museum or its community.

Laura Bush 21st Century Librarian Program

Institute of Musuem and Library Services (IMLS)

The program supports efforts to recruit and educate the next generation of librarians and the faculty who will prepare them for careers in library science. It also supports grants for research related to library education and library staffing needs, curriculum development, and continuing education and training. Program priorities are as follows: Priority 1: Master's Programs, Priority 2: Doctoral Programs, Priority 3: Pre-professional Programs, Priority 4: Research, Priority 5: Programs to Build Institutional Capacity, and Priority 6: Continuing Education and Training. Fifty percent of total project costs; funds requested for student support are not subject to matching requirement.
