# News from Congressman Ehlers ... HOUSE APPROVES TRANSPORTATION BILL; \$6.4B FOR MICHIGAN –

Michigan would get nearly \$200 million more per year in federal highway funding under legislation approved Thursday by the U.S. House of Representatives, Congressman Vernon J. Ehlers announced.

# THIS WEEK IN THE U.S. HOUSE OF REPRESENTATIVES MONDAY, MARCH 14, 2005

On Monday, the House will meet at 12:30 p.m. for morning hour and 2 p.m. for legislative business. Votes will be postponed until 6:30 p.m. **Suspensions** (14 bills):

(Bills on suspension are generally considered non-controversial and have reduced debate time, but require a two-thirds majority vote to be passed.)

1) H.R. 126 - To amend Public Law 89-366 to allow for an adjustment in the number of free roaming horses permitted in Cape Lookout National Seashore (*North Carolina*)

**2) H.R. 186 - Llagas Reclamation Groundwater Remediation Initiative:** Establishes within the Treasury an interest bearing account to be known as the California Basins Groundwater Remediation Fund, which shall be administered by the Secretary of the Interior, acting through the Bureau of Reclamation, in cooperation with the Santa Clara Valley Water District. It requires that the Fund be used by the Secretary to provide grants to reimburse the District for the Federal share of the costs associated with designing and constructing groundwater remediation projects.

3) H.R. 584 - Department of the Interior Volunteer Recruitment Act: Authorizes the Secretary of the Interior to recruit, train, and accept, without regard to the civil service classification laws, rules, or regulations, the services of individuals, contributed without compensation as volunteers, for aiding in or facilitating the activities administered by the Secretary through the Bureau of Indian Affairs, the U.S. Geological Survey, the Bureau of Reclamation, and the Office of the Secretary.

4) H.R. 486 - To provide for a land exchange involving private land and Bureau of Land Management land in the vicinity of Holloman Air Force Base, New Mexico,

for the purpose of removing private land from the required safety zone surrounding munitions storage bunkers at Holloman Air Force Base

5) H.R. 680 - To direct the Secretary of Interior to convey certain land held in trust for the Paiute Indian Tribe of Utah to the City of Richfield, Utah

6) H.R. 816 - Nevada National Forest Land Disposal Act of 2005: Requires the Secretary of Agriculture to sell at public auction any right, title, or interest of the United States in and to specified parcels of National Forest System lands in Carson City and Douglas County, Nevada.

7) H.R. 62 - To create the Office of Chief Financial Officer of the Government of the Virgin Islands: Requires the Governor of the Virgin Islands to appoint a Chief Financial Officer, with the advice and consent of the Legislature of the Virgin Islands, from a list required by this Act. States that if: (1) the Legislature has not confirmed a nominee within 90 days the Governor shall appoint an Acting Chief Financial Officer until the Legislature consents to a Chief Financial Officer; and (2) a Chief Financial Officer has not been appointed within 180 days the Virgin Islands Chief Financial Officer Search Commission shall appoint from such list an Acting Chief Financial Officer until a Chief Financial Officer is appointed. It sets forth the Chief Financial Officer's duties.

8) H.R. 412 - Western Reserve Heritage Areas Study Act (Ohio)

**9) H.R. 694** - **Gullah/Geechee Cultural Heritage Act:** Establishes the Gullah/Geechee Cultural Heritage Corridor (Heritage Corridor) to recognize the important contributions made to American culture and history by African-Americans known as the Gullah/Geechee who settled in the coastal counties of South Carolina, North Carolina, Florida, and Georgia;

10) H.R. 1160 - To reauthorize the Temporary Assistance for Needy Families block grant program through June 30, 2005

11) H.R. 1134 - To amend the Internal Revenue Code of 1986 to provide for the proper tax treatment of certain disaster mitigation payments

**12)** H.Res. 135 - Providing for the establishment of a commission in the House of Representatives to assist parliaments in emerging democracies

**13**) H.Res. 101 - Urging the European Union to add Hezbollah to the European Union's wide-ranging list of terrorist organizations

14) S. 384 - To extend the Nazi War Crimes and Japanese Imperial Government Records Interagency Working Group for 2 years

#### TUESDAY, MARCH 15, 2005

On Tuesday, the House will meet at 9 a.m. for morning hour and 10 a.m. for legislative business.

**H.R. XXX** - **Emergency Supplemental Wartime Appropriations Act:** In general, the bill funds urgent FY05 needs relating to prosecuting the war on terrorism and furthering specific U.S. security interests abroad. The Appropriations Committee proposes funding the request at \$81.3 billion, \$600 million less than requested by the president.

**H.Con.Res. XXX - Concurrent Resolution on the Budget for FY 2006**: Sets budgetary goals for Fiscal Year 2006.

#### On March 14 ...

**1900** - U.S. currency went on the gold standard with the ratification of the Gold Standard Act.

**1903** - The U.S. Senate ratified the Hay-Herran Treaty that guaranteed the U.S. the right to build a canal at Panama. The Columbian Senate rejected the treaty.

1923 - President Harding became the first U.S. President to file an income tax report.

**1989** - The U.S. Food and Drug administration decided to impound all fruit imported from Chili after two cyanide-tainted grapes were found in Philadelphia, PA.
