## A BILL

To establish the Congressional Teacher Award Task Force to enter into an agreement with a nonprofit entity for the operation of a program to recognize excellent elementary and secondary school teachers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Congressional Teacher  
5 Award Act of 2006”.

1 **SEC. 2. CONGRESSIONAL TEACHER AWARD TASK FORCE.**

2 (a) ESTABLISHMENT.—

3 (1) IN GENERAL.—There is hereby established  
4 the Congressional Teacher Award Task Force (here-  
5 after in this Act referred to as the “Task Force”),  
6 consisting of the following members:

7 (A) 6 members of the House of Represent-  
8 atives, of whom 3 shall be appointed by the  
9 Speaker of the House of Representatives and 3  
10 shall be appointed by the minority leader of the  
11 House of Representatives.

12 (B) 6 members of the Senate, of whom 3  
13 shall be appointed by the majority leader of the  
14 Senate and 3 shall be appointed by the minority  
15 leader of the Senate.

16 (2) CO-CHAIRS.—The members of the Task  
17 Force shall designate two of the members, of whom  
18 one shall be a member of the House of Representa-  
19 tives and the other shall be a member of the Senate,  
20 to serve as co-chairs of the Task Force.

21 (b) DUTIES.—It is the duty of the Task Force to find  
22 an appropriate nonprofit entity to operate the Congres-  
23 sional Teacher Award Program described in section 3.

24 (c) DEADLINE.—Not later than 1 year after the date  
25 of the enactment of this Act, the Task Force shall des-  
26 ignate a nonprofit entity which will enter into a written

1 agreement to operate the Congressional Teacher Award  
2 Program described in section 3.

3 (d) PAYMENT OF EXPENSES.—

4 (1) AUTHORIZATION OF APPROPRIATIONS.—

5 There are authorized to be appropriated from the  
6 applicable accounts of the House of Representatives  
7 and the contingent fund of the Senate (in such allo-  
8 cation as the Task Force may establish) such sums  
9 as may be necessary for the operation of the Task  
10 Force.

11 (2) VOUCHERS.—In the case of amounts paid  
12 from the applicable accounts of the House of Rep-  
13 resentatives, payments shall be made on vouchers  
14 signed by the co-chair who is a member of the  
15 House of Representatives and approved in the man-  
16 ner directed by the Committee on House Adminis-  
17 tration.

18 (e) TERMINATION.—The Task Force shall terminate  
19 upon the expiration of the 30-day period which begins on  
20 the date the nonprofit entity enters into the written agree-  
21 ment referred to in subsection (c).

22 **SEC. 3. CONGRESSIONAL TEACHER AWARD PROGRAM.**

23 (a) IN GENERAL.—The Congressional Teacher  
24 Award Program—

1           (1) shall provide an award each academic year  
2           to one excellent private or public elementary or sec-  
3           ondary school teacher in each congressional district  
4           of the United States (including each district of a  
5           Delegate or Resident Commissioner to the Con-  
6           gress); and

7           (2) may provide scholarships for professional  
8           development to teachers receiving an award under  
9           the Program.

10          (b) ELIGIBILITY REQUIREMENTS.—The Congres-  
11          sional Teacher Award Program shall include eligibility re-  
12          quirements for a teacher to qualify as a recipient of an  
13          award under the Program, including requirements that  
14          each such recipient—

15                (1) be certified as a teacher;

16                (2) have at least 5 consecutive years of teaching  
17                experience in private or public elementary or sec-  
18                ondary school;

19                (3) demonstrate—

20                      (A) a commitment of service to his or her  
21                      school;

22                      (B) maintenance of high academic stand-  
23                      ards for students; and

24                      (C) incorporation of multiculturalism, tech-  
25                      nology, interdisciplinary studies, student rel-

1 evance, and current issues in lessons, classroom  
2 activities, and special presentations; and  
3 (4) provide 3 letters of recommendation, includ-  
4 ing a letter from each of a principal, a fellow teach-  
5 er, and a student.
