

## LEGISLATION CO-SPONSORED BY REP. GUTKNECHT

**THE REAL ID ACT OF 2005 (HR 418):** Establishes regulations for state driver's license and ID document security standards; prevents terrorists from abusing U.S. asylum laws; unifies terrorism-related grounds for inadmissibility and removal and ensures construction of the San Diego border fence. *Passed and signed.*

**CITIZENSHIP REFORM ACT OF 2005 (HR 698):** Amends the Immigration and Nationality Act to deny citizenship at birth to children born in the U.S. of parents who are not citizens or permanent resident aliens. *Pending.*

**SECURITY AND FAIRNESS ENHANCEMENT FOR AMERICA ACT OF 2005 (HR 1219):** Amends the Immigration and Nationality Act to eliminate the diversity immigrant program. *Pending.*

**CLEAR ACT OF 2005 (HR 3137):** Allows local law enforcement to arrest and detain illegal aliens. *Pending.*

**CRIMINAL ALIEN ACCOUNTABILITY ACT (HR 3150):** Amends the Immigration and Nationality Act to impose mandatory sentencing ranges with respect to aliens who re-enter the U.S. after having been deported. *Pending.*

**BORDER PROTECTION CORPS ACT (HR 3622):** Authorizes the governor of a state to organize and call into service able-bodied and eligible citizens to help prevent individuals from unlawfully entering the United States. *Pending.*

**H. CON. RES 50:** Non-binding resolution which states disapproval of the US-Mexico totalization agreement on Social Security checks. *Pending.*

## DEMOGRAPHICS

Forty-two percent of births to immigrants are to illegal alien mothers. In 2005, births to illegal aliens will account for one in 10 births in the United States.

In the three months following the announcement of the Administration's willingness to permit foreigners already working inside the United States to participate in its temporary worker program, the number of illegal aliens apprehended along the southwestern border soared 25 percent over the same period during the previous year.

Snapshot of a typical illegal alien:

- Age: 32
- Average household: four people
- Average education: seven years
- Hourly wage: \$5.45
- Annual individual income: \$8,982
- Annual family income: \$15,364.

At the time of this survey, many of the illegal aliens were well established, having lived in the United States for more than 10 years.

Estimate of illegal aliens in Minnesota: 60,000 to 94,000.

## HEALTH CARE

Illegal aliens are eligible for emergency Medicaid services and emergency medical services provided by the states.

For each fiscal year (FY2005-FY2008), the Medicare bill passed in 2003 will appropriate \$250 million to states to be distributed based on the following criteria:

- \$167 million is allotted to states based on the percentage of unauthorized aliens residing in the state compared to the total number of unauthorized aliens in the United States; and
- \$83 million is allocated to the six states with the highest percentage of unauthorized alien apprehensions.

## EDUCATION

K-12 expenditures for illegal alien children total \$12 billion per year while expenditures for illegal alien children plus children born in the United States to illegal aliens total \$28.6 billion per year.

The cost to educate children of illegal aliens in Minnesota in 2004 was \$276.6 million.

## CRIME

Currently, criminal aliens account for more than 29 percent of prisoners in Federal Bureau of Prisons facilities.

Incarceration of criminal aliens costs an estimated \$624 million to state prisons in 1999 and \$891 million to federal prisons in 2002.

From 1995 to 2000, Immigration and Naturalization Services released more than 35,000 criminal aliens instead of deporting them. More than 11,000 of those released went on to commit serious crimes – 1,800 of which were violent, including 98 homicides, 142 sexual assaults and 44 kidnappings.

## LABOR

Fifty-five percent of hired farm workers are unauthorized to work in the United States.

Sixty to 70 percent of seasonal agriculture workers provide fraudulent documents, according to audits by United States Immigration and Customs Enforcement.
