Prescription Drug Discount Card

- Immediate help is available to make prescription drugs more affordable for all seniors thorough a voluntary prescription drug card.
- Seniors save 10-25% off the costs of most medicines through this card, which is approved by the Medicare program.
- Seniors simply take the card to their local pharmacy and receive the discount.
- All seniors can begin applying for the card after May 3rd and start using them on June 1st.
- About 7 million low-income seniors will qualify for additional federal subsidies of \$1,200 to help purchase prescription drugs for the 18 month period starting June 1, 2004.
- 173,000 Missouri seniors at low incomes will receive an additional \$600 subsidy, along with the discount card, to help purchase drugs in 2004 and 2005. That is a total of \$208 million in low-income assistance to Missouri alone.





Seniors Who Need the Most Help Receive the Most Help

- 888,000 Missouri seniors will have access to a Medicare prescription drug benefit for the first time in Medicare's 40 year history beginning in 2006, including 214,000 seniors without current coverage for prescription drugs.
- 269,000 low income seniors in Missouri (with incomes below 135% of federal poverty level and limited savings) will pay no premiums, no deductibles, no gap in coverage and no more than \$2 per prescription for generic drugs and \$5 per prescription for brand name drugs.
- 62,000 additional low-income seniors in Missouri (with incomes between 135% of federal poverty level and limited savings) will pay premiums on a sliding scale, a \$50 deductible, and 15% of drug costs with no gap in coverage. After spending \$3,600 out-of-pocket in a year, copayments will be \$2 for generic drugs and \$5 for brand name drugs.

Voluntary Prescription Drug Benefit



- For the first time ever, America's seniors enrolled in the Medicare program have access to a prescription drug benefit.
- Seniors choose the benefit that best fits their needs. Either a standard benefit administered by the Medicare Program, or a benefit offered through a private provider. A benefit offered by a private provider must be equal in value to the standard benefit, which includes:
 - A monthly premium of about \$35
 - A deductible of \$250
- Prescription drug coverage is 75% up to \$2250
- Protection from high out-of-pocket costs. When total spending reaches \$3600, copays are \$2 for generics and \$5 for brand-name drugs.
- Here is a sampling of what popular prescription drugs will cost under the new Medicare law (examples are for a 30 tablet prescription):

 Lopressor:
 \$9.20 instead of \$45.99

 Imdur:
 \$9.78 instead of \$48.89

 Lipitor:
 \$21.73 instead of \$108.65

 Fosamax:
 \$16.09 instead of \$80.45

 Celebrex:
 \$17.26 instead of \$86.28

Better Medicare

- Traditional Medicare is strengthened and improved to keep up with advancements in health care, including disease management and preventive care.
- Seniors can have a "Welcome to Medicare" physical, which includes service such as vaccinations, cancer screening, diabetes self-management, glaucoma screening, cardiovascular screening, and more.
- Preventive care is expanded under a better Medicare. Preventive care pays for a senior to stay healthy. For example, under the old system, Medicare would pay for the amputation of a diabetic's limb, but not the medicine that would have prevented such drastic surgery.
- Health Savings Accounts that will allow individuals to set aside tax-free, portable, savings for lifetime health care needs where contributions can be made by individuals, employers and family members.
- Better Medicare means that seniors have choices:
 - Seniors can choose to stay in traditional Medicare.
 - Seniors can choose to stay in traditional Medicare and choose a Medicaresponsored prescription drug benefit.
 - Seniors can choose a Medicare-Advantage plan, which offers the same types of health care insurance available to Members of Congress and other federal employees.
