Dear Friends,

While our nation remains focused on helping the victims of Hurricane Katrina and Hurricane Rita recover, I still remain concerned by the Bush Administration's determination to create private accounts within the Social Security program. I recently released a report analyzing the impact of the President's Social Security plan on Maryland.

The report - *The Impact of President Bush's Social Security Proposal in Maryland* - was prepared by the Committee on Government Reform minority staff, and it found that if the President's plan were enacted 1.8 million workers in Maryland would see a reduction in their benefits. Marylanders between the age of 33 and 55 would see their benefits cut by \$2,555 a year, and younger workers would see their benefits cut by even more -- \$5,565 per year.

I do not believe that Americans want to see an end to the "guaranteed benefit" provided for 70 years under the Social Security program. And, I do not believe such a dramatic change in the program is needed.

In fact, the Social Security Trustees have stated that the program is fully solvent for another 36 years, until 2041. I support a bipartisan solution that will ensure long-term solvency. Let's not fundamentally change an program that we know works.
