# **Bills Signed into Law**

# September 2004

Total number of bills and resolutions signed into law in September 2004: 8

Total costs of bills signed into law in September 2004:

- Authorizations over five years: \$16.87 billion\*
- Net change in mandatory spending over five years: +\$586.0 million
- Appropriations for fiscal year 2004: \$2.0 billion
- Appropriations for fiscal year 2005: **\$0**
- Net change in federal revenue over five years: \$0

#### H.R. 5005

Public Law 108-303

Making emergency supplemental appropriations for the Federal Emergency Management Administration for the fiscal year ending September 30, 2004

Signed into law: September 8, 2004

Cost: Appropriates \$2.0 billion in emergency spending for fiscal year 2004

#### H.R. 361

Public Law 108-304

Sports Agent Responsibility and Trust Act

Signed into law: September 24, 2004

<u>Cost</u>: Authorizes \$2.5 million over five years

#### H.R. 3908

Public Law 108-305

To provide for the conveyance of the real property located at 1081 West Main Street in Ravenna, Ohio

Signed into law: September 24, 2004

<u>Cost</u>: No significant cost to taxpayers

#### H.R. 5008

Public Law 108-306

To provide an additional temporary extension of programs under the Small Business Act and the Small Business Investment Act of 1958 through September 30, 2004

Signed into law: September 24, 2004

Cost: No cost above the baseline

## <u>S. 1576</u>

Public Law 108-307

Harpers Ferry National Historical Park Boundary Revision Act

Signed into law: September 24, 2004

<u>Cost</u>: Authorizes \$5.6 million over five years

### H.R. 5149

Public Law 108-308

To reauthorize the Temporary Assistance for Needy Families block grant program through March 31, 2005

Signed into law: September 30, 2004

<u>Cost</u>: Increases mandatory spending by \$493.0 million above the baseline over five years

#### H.J.Res. 107

Public Law 108-309

Making Continuing Appropriations for the Fiscal Year 2005

Signed into law: September 30, 2004

<u>Cost</u>: No new appropriations above the baseline

#### H.R. 5183

Public Law 108-310

Surface Transportation Extension Act, Part V

Signed into law: September 30, 2004

<u>Cost</u>: Increases contract authority (a mandatory form of budget authority) by \$16.86 billion over five years and increases mandatory spending by \$93.0 million over five years.
