Public Law 108-67

To direct the Secretary of Agriculture to convey certain land in the lake Tahoe Basin Management Unit, Nevada, to the Secretary of the Interior, in trust for the Washoe Indian Tribe of Nevada and California

Signed into law: August 1, 2003

Cost: No significant cost to taxpayers

Signed into law: August 8, 2003

Cost: Appropriates \$983.6 million in fiscal year 2003

Signed into law: August 14, 2003

Cost: No significant cost to taxpayers

Signed into law: August 15, 2003

To amend title XXI of the Social Security Act to extend the availability of allotments for fiscal years 1998 through 2001 under the State Children's Health Insurance Program

Signed into law: August 15, 2003

Cost: No significant cost to taxpayers

Public Law 108-75

Mosquito Abatement for Safety and Health Act

Signed into law: August 15, 2003

Cost: Authorizes \$679.0 million over five years
