Child Nutrition and WIC Reauthorization Act

Signed into law: June 30, 2004

<u>Cost</u>: Increases mandatory spending by \$184 million over five years and authorizes \$23.37 billion over five years. This authorization figure was estimated from informal information from CBO and from RSC staff analysis. It should be regarded as a significant underestimation of the actual authorizations.
