Loans:

- \$2 Billion in guaranteed loans to Egypt (with Egypt paying the costs of guaranteeing the loans)
- \$8.5 Billion in guaranteed loans to Turkey (with Turkey paying the costs of guaranteeing the loans)
- \$9 Billion in guaranteed loans to Israel (with Israel paying the costs of guaranteeing the loans)

General Provisions of Note:

- Allows for relief and reconstruction of Iraq notwithstanding any other provisions of law
- Repeals the Iraq Sanctions Act of 1990
- Permits the President to authorize otherwise restricted exports to Iraq
- Lifts the \$1 million cap on assistance provided by the Department of HHS to ill or destitute US citizens returning from foreign countries due to war
- Various provisions to provide the Department of Defense with transfer authority, permit
 minor construction projects, permits additional emergency expenditures, permits
 expanded use of cooperative threat reduction funds
