## A BILL

- To amend titles XVIII, XIX, and XXI of the Social Security Act to provide benefits improvements and beneficiary protections in the medicare and medicaid programs and the State child health insurance program (SCHIP), as revised by the Balanced Budget Act of 1997 and the Medicare, Medicaid, and SCHIP Balanced Budget Refinement Act of 1999, and for other purposes.
- Be it enacted by the Senate and House of Representatives
   of the United States of America in Congress assembled,

### SECTION 1. SHORT TITLE; AMENDMENTS TO SOCIAL SE-CURITY ACT; REFERENCES TO OTHER ACTS; TABLE OF CONTENTS.

(d) Payment for New Technologies.—

(1) Tests furnished in 2001.—

(A) SCREENING.—For a screening mammography (as defined in section 1861(jj) of the Social Security Act (42 U.S.C. 1395(jj))) furnished during the period beginning on April 1, 2001, and ending on December 31, 2001, that uses a new technology, payment for such screening mammography shall be made as follows:

(i) In the case of a technology which directly takes a digital image (without involving film) and subsequently analyzes such resulting image with software to identify possible problem areas, in an amount equal to 150 percent of the amount of payment under section 1848 of such Act (42 U.S.C. 1395w-4) for a bilateral diagnostic mammography (under HCPCS code 76091) for such year.

(ii) In the case of a technology which allows 29 conversion of a standard film mammogram into a 30 digital image and subsequently analyzes such re-31 32 sulting image with software to identify possible problem areas, in an amount equal to the limit that 33 would otherwise be applied under 34 section 1834(c)(3) of such Act (42 U.S.C. 1395m(c)(3)) 35 for 2001, increased by \$15. 36

(B) BILATERAL DIAGNOSTIC MAMMOGRAPHY.-1 2 For a bilateral diagnostic mammography (under HCPCS code 76091) furnished during the period be-3 ginning on April 1, 2001, and ending on December 31, 4 2001, that uses a new technology described in subpara-5 graph (A) (i), payment for such mammography shall be 6 the amount of payment provided for under such sub-7 paragraph. 8

9 The Secretary of Health and Human Services may imple-10 ment the provisions of this paragraph by program memo-11 randum or otherwise.

(2) CONSIDERATION OF NEW HCPCS CODE FOR NEW 12 TECHNOLOGIES AFTER 2001.—The Secretary shall deter-13 mine, for such screening mammographies performed after 14 2001, whether the assignment of a new HCPCS code is ap-15 propriate for screening mammography that uses a new 16 17 technology. If the Secretary determines that a new code is appropriate for such screening mammography, the Sec-18 retary shall provide for such new code for such tests fur-19 nished after 2001. 20

(3) NEW TECHNOLOGY DESCRIBED.—For purposes of
this subsection, a new technology with respect to a screening mammography is an advance in technology with respect
to the test or equipment that results in the following:

25 (A) A significant increase or decrease in the re26 sources used in the test or in the manufacture of the
27 equipment.

28 (B) A significant improvement in the performance29 of the test or equipment.

30 (C) A significant advance in medical technology
31 that is expected to significantly improve the treatment
32 of medicare beneficiaries.
