Dear Neighbor:

Social Security is a program that helps all Americans and now this benefit is under serious debate.

We currently face decisions regarding Social Security, which is the single largest source of income for retirees in the United States and keeps 12 million seniors out of poverty.

On the national level African Americans, for example, are 10% of the US labor market, but 17% of the disabled workforce. Social Security matters to families of those who are disabled.

While social security is the only source of income for 22% of the retired U.S. population, 70% of all elderly people of African descent rely on it. Social Security matters for our parents, grandparents, aunts and uncles.

A number of cases that my office handles on social security relates to survivor benefits. The survivors are often women and children. This is because Black men have the lowest life expectancy rates of all the major population groups. About 23% of all children receiving survivor benefits are of African descent.

Without the current Social Security funding levels, the rate of poverty among African American seniors would go from 24% to 64%. The basic fact is that the current Social Security system provides critical economic assistance for the families of African descent whose loved ones become disabled or die in the prime of their working lives.

One of the dangerous deals under consideration in Washington involves moving the age at which people reach full eligibility from 68 to 70 years of age. I look forward to hearing from you at this most critical juncture in our nation's history.

HANDLING DEPORTATION THE SMART WAY

eportation is on the rise. My office receives calls daily from parents, children and spouses of immigrants facing deportation. Take the case of a United States Marine Corporal who after serving honorably in Iraq and being decorated for heroism found himself in deportation. My office stepped in and was able to get him released from detention and is continuing to work to get his original court martial vacated so he will not get picked up again. In a democracy everyone has rights so here are some suggestions if you have problems.

- Don't say anything: Do not answer ANY questions, not even your name, immigration status or country of origin. Ask to speak to an attorney.
- Don't sign anything: If an agent asks for your signature, ask for a copy of the papers but do NOT sign. Show the paper to your attorney.
- Don't lie: Say nothing or say, "I need to speak with a lawyer first."
- Ask to speak with your attorney: You should request a letter from your attorney stating that s/he does not permit immigration agents to interview you. If they keep insisting that you answer the question, just state," I want to stop this interview now."

Given the population mix of the 11th Congressional District, 99% of casework in my office deals with immigration concerns. The word is out that the assistance that we provide brings benefits to many who have been waiting years for responses on becoming a U.S. citizen. In March 2005, we serviced 276 immigration cases. Constituent Rescued from Kidnapping In Pakistan FBI, State Department & Pakistani Law Enforcement Acted in Good Faith

ost of the constituent work in my office is routine -- handling social security, military, Medicare, and immigration cases. In January of this year, our routine work turned to high drama when a constituent in Pakistan was kidnapped after ID-ing a suspect following a robbery in which his wife was tragically killed.

The constituent's family contacted my office and we in turn contacted the State Department who assigned an FBI agent to the case. Soon local Pakistani officials set up checkpoints around the city. Several suspects were arrested and one of them revealed the location of the kidnappers. The kidnappers were arrested and led the police to the shed where the constituent was finally freed after 8 days in captivity.

Visa Denial Reversed

here are countless reasons for denying a visa to a non-citizen. But when 18-year-old Hopestar, who had lost all her skin on her right arm following a tragic car accident was denied a visa for the operation that could not have been performed in Ghana, my office stepped in and the State Department issued Hopestar a humanitarian parole. She has successfully completed her surgery and is on her way to recovery.

EDUCATION ALERT: EMERGENCIES AND OPPORTUNITIES

he court has ordered the New York State Legislature to give New York City schools an additional \$9.2 billion to improve school facilities and \$5.6 billion each year for operating aid. All constituents are urged to monitor the response of the legislature to the judge's order because with the Federal budget cuts NYC needs all the money it can get for education.

On the Federal side proposed cuts amount to almost \$1 billion from the NYC programs needed to meet the requirements of No Child Left Behind. Other significant Federal education cuts in the 2006 budget include wiping out \$1.3 billion for all vocational education programs, \$522 million for all education technology programs, \$29 million for all civic education programs, \$225 million for the Even Start family literacy program, and \$437 million in state grants for safe and drug-free schools and communities. It is possible that the Congress will change these cuts prior to the final appropriation. Renovation Funds for One-Family Homes

he Erasmus Neighborhood Federation received a \$300,000 affordable housing grant from funds provided by DHRC'S HOME PRO-GRAM, which is administered by the New York State Housing Trust Fund Corporation for 20 owner-occupied units. The HOME PROGRAM uses Federal funds to expand the supply of decent, safe, and affordable housing by providing funds to acquire and rehabili-

tate homes. For 2005, \$33.5 million have been allocated for New York State. You can get up to \$20,000 to renovate your one-family home if you live in East Flatbush, Crown Heights, Brownsville and Ocean Hill.
