

Bills Signed into Law June 2003

Total number of bills and resolutions signed into law in June 2003: 10

<u>H.R. 192</u>

Public Law 108-31

To amend the Microenterprise for Self-Reliance Act of 2000 and the Foreign Assistance Act of 1961 to increase assistance for the poorest people in developing countries under microenterprise assistance programs under those Acts

Signed into law: June 17, 2003

Cost: Authorizes \$375.0 million over five years

Grand Teton National Park Land Exchange Act

Signed into law: June 17, 2003

<u>Cost</u>: Authorizes \$1.0 million over five years

Signed into law: June 23, 2003

Signed into law: June 23, 2003

Cost: Authorizes \$19.0 million over five years

Public Law 108-38

Expressing the sense of Congress with respect to raising awareness and encouraging prevention of sexual assault in the United States and supporting the goals and ideals of National Sexual Assault Awareness and Prevention Month

Signed into law: June 26, 2003

Cost: No significant cost to taxpayers

Signed into law: June 30, 2003

Temporary Assistance for Needy Families block grant program Reauthorization Act of 2003

Signed into law: June 30, 2003

<u>Cost</u>: Increases mandatory spending by \$26.0 million in FY2003 and by \$177.0 million over the FY2003-2007 period
