Appropriations Policy Brief

H.R. 2528 — Military Quality of Life Appropriations Act for FY 2006

Excluding Emergency Appropriations, the Committee Bill is:

- > \$5.2 billion (6.5%) more than last year
- > \$723 million (1%) more than the request

Budget Compliance: According to CBO, the bill is within the 302(b) allocation of the Military Quality of Life and Veterans Affairs Appropriations Subcommittee and thus complies with the Budget Act.

<u>Unauthorized Appropriations</u>: According to the Committee report, the bill appropriates \$54.2 billion for unauthorized programs, 63.6% of the bill. The Rules of the House prohibit this practice, but the rule governing consideration of the bill is expected to waive this restriction. However, many of these programs will receive their authorization with the enactment of H.R. 1815, the FY06 Defense Authorization Act.

Presidential Terminations and Reductions:

State Extended Care Facilities: Increases funding for grants to construct new state extended care facilities from \$31.7 million to \$32 million. The Administration proposed to halt funding for new facilities until a nationwide study could be undertaken on where veterans with service-connected disabilities reside in greatest numbers. Accordingly, the request contained no funding for this account.

Items of Note:

Veterans Medical Care: Increases veterans medical care by \$1.68 billion from \$19.3 billion to \$21 billion, an increase of \$1.7 billion or 9% over last year and \$1 billion or 5% over the request. The bill does **NOT** contain the Administration's proposals to increase co-pays and deductibles.

Base Realignment and Closure (BRAC): Increases funding for the BRAC process by \$1.7 billion, from \$246 million to \$1.95 billion, to accommodate the new 2005 round of base closings. This funding level is \$310 million below the President's request. The Base Closure Commission will make its recommendations (based upon the Department of Defense's recent submissions) in September and implementation will begin in 2006. In its Statement of Administration Policy on H.R. 1815, the FY06 Defense Authorization Act, the Administration strongly opposed this proposed \$310 million reduction from its request, claiming it would "slow BRAC implementation and thus delay achievement of the mission improvements provided by BRAC changes, costing the DOD more money over the long-term."

Contracting Restrictions: Prohibits funds from spent on "cost-plus-a-fixed-fee" construction contracts if they exceed \$25,000 – except for contracts in Alaska. Under cost-plus-fixed fee contracts, a contractor is less responsible for the actual costs of performing the contract because the profit has already been negotiated.

Flag Officer Renovations: Limits the amount of funding for renovating a general or flag officers quarters to \$35,000 per year. Last year, the Committee expressed concern in report language that a substantial portion of major renovation costs were customer driven or demanded by officers residing in those quarters (according to a GAO investigation).

Earmarks:

On pages 72 through 90, the Committee Report lists its recommendations for military construction and housing projects by state.
