FEDERAL MARRIAGE AMENDMENT (FMA)

Background and talking points

WHAT DOES THE FMA SAY?

Marriage in the United States shall consist only of the union of a man and a woman. Neither this Constitution or the constitution of any State, nor state or federal law, shall be construed to require that marital status or the legal incidents thereof be conferred upon unmarried couples or groups.

WHY IS FMA NECESSARY?

- A majority of the American people believe that marriage ought to be defined as the union of a man and woman
- Activist courts are circumventing that sentiment by overturning laws and redefining how our culture views and defines the institution of marriage.

WHAT DOES FMA DO?

- FMA prevents courts from redefining marriage
- It clearly defines marriage in the constitution as the "union of a man and a woman"
- It prevents courts from forcing states to adopt civil unions.
