#### **Real I.D. for Real People**

It is simple commonsense that people in our country illegally should not be rewarded with a driver's license to use as a legal form of ID, right? I thought so, and that is why during the debate on the Intelligence bill last year, I brought the issue of states providing drivers' licenses to illegal aliens to the national forefront. I also agreed with what the bipartisan 9/11 Commission said about this problem - that this is not just an issue about identity theft; this is an issue of security.

Commonsense, however, is not that common in the US Senate. As a result of the Senate's unwillingness to compromise on the driver's license provisions, the bill that was signed into law by President Bush last year was flawed, and I did not support it.

HR 418, the Real ID Act, is my remedy to the situation. Passed by the House of Representatives on February 10, my bill's goal is straightforward: it seeks to prevent another 9/11-type attack by disrupting terrorist travel. This legislation addresses the use of a driver's license as a form of identification to a federal official. American citizens have the right to know who is in our country, that people are who they say they are, and that the name on a driver's license is the holder's real name, not some alias. My bill does not try to set state policy for who may or may not drive a car.

The Real ID Act will also tighten our asylum system, which has been abused by terrorists. The 9/11 Commission staff report on terrorist travel states that, "once the terrorists had entered the United States, their next challenge was to find a way to remain here. Their primary method was immigration fraud."

While I have no problems with legal immigration, I do have a problem with illegal immigra-

#### **It's Time for Permanent Tax Relief**

By now, chances are you've either paid your taxes, or are scrambling to do so before the April 15<sup>th</sup> deadline. If you're lucky, you were able to file your taxes without assistance, and it "only" took you a few hours. However, the numbers don't favor you. Over half the individual income tax returns filed a couple of years ago required the assistance of a professional preparer. Though numbers for people filing this year are not yet available, it's difficult to imagine that the need for professional preparers has gone down.

## Sensenbrenner Receives Award from Women's Caucus

tion, especially when it leads to the loss of innocent lives. I am reminded here of the February news account of the illegal alien from Macedonia who killed a family of four in a Tennessee traffic accident three days after illegally procuring a Wisconsin commercial truck driver's license.

This was one of the reasons why I was pleased to join State Representative Mark Gundrum of New Berlin in holding a press conference at Mitchell Field to introduce Wisconsin's Identification Security Act. Echoing my sentiments, Mr. Gundrum spoke about the need to address this important security issue now, so we don't regret it in the months and years to come.

I'm glad that my message in Washington was heard here in Wisconsin, especially since Wisconsin is one of about 10 states that still issues drivers' licenses to illegal aliens. It is my hope that my bill on the federal level, and Representative Gundrum's bill in Wisconsin, will help solve this security and safety problem by preventing an illegal immigrant from being issued a license to kill in the United States.

fy the tax code, at least we have succeeded in passing important tax relief to help Americans and businesses with some of their tax woes. As the year progresses, I look forward to working with my colleagues in the House to provide lasting tax relief once and for all because taxes are too complicated, too high, and a pain to file. You shouldn't need a degree in accounting, or have to spend hundreds of dollars on an accountant to do your taxes. Consequently, as Tax Day draws near, the date serves as a good reminder to Congress that we need to continue to push for tax simplification. The time to give our overtaxed nation some permanent relief is long overdue.
