Dear Representatives Stark and Miller:

We are writing to express our support for the "Paid Family and Medical Leave Act of 2005," your legislation to help America's working families maintain their economic security while meeting family and medical needs. The "Paid Family and Medical Leave Act of 2005" provides workers with 55 percent of their wages for up to 12 weeks annually to care for a newborn, newly adopted or foster child, disabled family members or to take care of their own serious illness.

Thanks to the Family and Medical Leave Act (FMLA), more than 50 million working Americans have benefited from unpaid, job-protected leave since its passage 12 years ago. However, because the FMLA guarantees only *un*paid leave, many women and men are unable to take essential time off when a new baby arrives or a medical crisis strikes. More than three in four (78%) FMLA eligible employees who needed but did not take FMLA leave report that they simply could not afford to take unpaid leave.

The need for this legislation will continue to grow as changing demographics, such as the aging of the U.S. population, increase employees' family responsibilities. The "Paid Family and Medical Leave Act of 2005" would help address these changes by assuring that workers continue to receive some income when they take leave to meet key family responsibilities or to recover from a serious illness that interrupts their ability to act as the family's breadwinner. This legislation will also benefit businesses with cost savings from increased employee retention, health care savings, and through associated increases in productivity and morale.

America's working families need the "Paid Family and Medical Leave Act of 2005" to help them balance the demands of work and family. On behalf of our many members and the millions of families that will benefit from your legislation, we want to thank you for your leadership on this important issue.
