# Dear Representative Stark:

On behalf of the 60,000 primary care pediatricians, pediatric medical subspecialists and pediatric surgical specialists of the American Academy of Pediatrics, I write today to endorse the AmeriCare Health Care Act of 2006. As the lead sponsor of Medikids, we have been pleased to work with you in a joint effort towards providing all children with the quality health insurance they deserve. We commend you for your efforts.

Children need coverage like that provided in Medikids. There are over eight million uninsured children in the United States, and they are 10 times as likely to go without the health care they need as those with insurance. Uninsured children who have asthma, for instance, are 75 percent less likely to see a physician when they need to than those with insurance.

Additionally, children would benefit from the passage of Americare. Simply put, insurance for other family members improves a child's chance at a healthy life. Astoundingly, children born into an uninsured household in the United States are 50 percent more likely to die before their first birthday (2005 United Nations Human Development Report). Clearly, a child's health is impacted by the health of his or her family.

The introduction of AmeriCare is another important step in furtherance of the goal of universal coverage for children and improvement in their health status. We look forward to advancing children's health coverage as the legislative process further refines the general ideas contained in AmeriCare.
