## A BILL

To ensure that the Department of Energy has appropriate mechanisms to independently assess the effectiveness of its policy and site performance in the areas of safeguards and security and cyber security.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. OFFICE OF INDEPENDENT SECURITY OVER-
- 4 SIGHT.
- 5 (a) Office.—The Secretary of Energy shall main-
- 6 tain an Office of Independent Security Oversight, which

- 1 shall be headed by a Director appointed by the Secretary
- 2 without regard to political affiliation and solely on the
- 3 basis of integrity and demonstrated ability in the oversight
- 4 and evaluation of security for nuclear and classified pro-
- 5 grams. The Director shall report directly to and be under
- 6 the general supervision of the Secretary, but shall not re-
- 7 port to or be subject to supervision by any other office
- 8 of the Department of Energy. The Secretary shall not pre-
- 9 vent, prohibit, or delay the Director from initiating, car-
- 10 rying out, or completing any inspection, evaluation, or re-
- 11 port undertaken pursuant to this Act. Such Office shall
- 12 be responsible for carrying out the missions and functions
- 13 described in subsections (b) and (c).
- 14 (b) SAFEGUARDS AND SECURITY EVALUATIONS.—
- 15 (1) Mission.—The Office of Independent Secu-
- rity Oversight shall be responsible for the inde-
- pendent evaluation of the effectiveness of safeguards
- and security policies, practices, and programs
- throughout the Department of Energy (including the
- National Nuclear Security Administration), includ-
- 21 ing protection of special nuclear material, protection
- of classified and sensitive information, personnel se-
- curity, and foreign visits and assignments. The Of-
- 24 fice shall develop and validate reports that identify
- findings and issues, and make recommendations for

- improvement. It also shall perform timely followup reviews to ensure that corrective actions are effective, and conduct complex-wide studies of security issues and generic weaknesses in safeguards and security.
  - (2) Functions.—The Office of Independent Security Oversight shall perform the following functions:
    - (A) Conduct regular evaluations, at least once every 18 months at each site, of safeguards and security programs at Department of Energy sites that have significant amounts of special nuclear material, classified information, or other security interests. The scope of the evaluations shall include all aspects of safeguards and security, including physical protection of special nuclear material, accountability of special nuclear material, protection of classified and sensitive information, personnel security, and foreign visits and assignments.
    - (B) Perform regular assessments of nuclear materials assurance at Department of Energy sites.

1	(C) Evaluate and assess Department of
2	Energy policies related to safeguards and secu-

4	(D) Perform timely followup reviews to en-
5	sure that corrective actions are effective.
6	(E) Perform complex-wide studies of issues
7	and generic weaknesses in safeguards and secu-

9	(F) Develop and validate reports that iden-
10	tify findings and issues, and make recommenda-
11	tions for improvement.
12	(G) Review other government and commer-
13	cial safeguards and security programs to pro-
14	vide a benchmark for Department of Energy
15	performance.
16	(H) Develop recommendations and oppor-
17	tunities for improving safeguards and security
18	for submittal to the Secretary.
19	(I) Any other function the Secretary con-
20	siders appropriate and consistent with the mis-
21	sion described in paragraph (1).
22	(c) Cyber Security.—
23	(1) Mission.—The Office of Independent Secu-
24	rity Oversight shall be responsible for the inde-
25	pendent evaluation of the effectiveness of classified

and unclassified computer security policies and programs throughout the Department of Energy (including the National Nuclear Security Administration). This consists of establishing and maintaining a continuous program for assessing Internet security to include offsite scanning and controlled penetration attempts to detect vulnerabilities that could be exploited by hackers. The Office shall also conduct timely followup reviews to ensure that corrective actions are effective, and perform complex-wide studies and analyses of events associated with computer security programs.

- (2) Functions.—The Office of Independent Security Oversight shall perform the following functions:
  - (A) Conduct regular evaluations of classified and unclassified computer security programs at Department of Energy sites, with sites having significant amounts of special nuclear material, classified information, or other security interests being evaluated at least once every 18 months.
  - (B) Establish and maintain a continuous program for assessing Internet security to include offsite scanning and controlled penetra-

1	tion attempts to detect vulnerabilities that could
2	be exploited by hackers and ensure they are
3	corrected by line management.
4	(C) Evaluate and assess Department of
5	Energy policies related to classified and unclas-
6	sified computer security.
7	(D) Perform timely followup reviews to en-
8	sure that corrective actions are effective.
9	(E) Perform complex-wide studies of issues
10	and generic weaknesses in computer security
11	programs.
12	(F) Develop and validate reports that iden-
13	tify findings and issues, and make recommenda-
14	tions for improvement.
15	(G) Review other government and commer-
16	cial computer security programs to provide a
17	benchmark for Department of Energy perform-
18	ance.
19	(H) Develop recommendations and oppor-
20	tunities for improving cyber security for sub-
21	mittal to the Secretary.
22	(I) Any other function the Secretary con-
23	siders appropriate and consistent with the mis-
24	sion described in paragraph (1).

## 1 SEC. 2. REPORTS TO CONGRESS.

2	(a) Report by Office.—The Office of Independent
3	Security Oversight shall, before February 15 of each year,
4	transmit to the Secretary of Energy and to the Congress
5	an unclassified report, with a classified appendix if re-
6	quested or necessary, summarizing the activities of the Of-
7	fice during the immediately preceding calendar year. Such
8	report shall include—
9	(1) an overview of the status of security at the
10	Department of Energy in the areas of responsibility
11	of that Office;
12	(2) a description of significant problems and de-
13	ficiencies, by site if applicable, identified in such se-
14	curity areas;
15	(3) a description of recommendations for cor-
16	rective action made by the Office during the report-
17	ing period with respect to significant problems or de-
18	ficiencies identified pursuant to paragraph (2);
19	(4) the adequacy of corrective actions, if any,
20	taken by the Department to address such problems
21	and deficiencies;
22	(5) an identification of each significant problem
23	or deficiency described in previous annual reports on
24	which corrective action has not been effectively com-
25	pleted:

1	(6) a summary of each significant report made
2	to the Secretary pursuant to this Act during the re-
3	porting period;
4	(7) a description and explanation of the reasons
5	for any significant revisions to security policy deci-
6	sions made during the reporting period; and
7	(8) a description of any significant security pol-
8	icy decision with which the Director is in disagree-
9	ment.
10	(b) REPORT BY SECRETARY.—The Secretary of En-
11	ergy shall, before March 15 of each year, transmit to the
12	Congress an unclassified report, with a classified appendix
13	if requested or necessary, summarizing the Secretary's re-
14	sponse to the Office's annual report submitted under sub-
15	section (a). Such report from the Secretary shall include—
16	(1) an identification of each significant prob-
17	lem, deficiency, or recommendation identified in the
18	Office's annual report with which the Secretary is in
19	disagreement;
20	(2) an explanation of the reasons for any fail-
21	ure on the part of the Department of Energy to
22	complete effectively corrective actions recommended
23	by the Office in its previous annual reports; and

- 1 (3) a description of the Secretary's response to
- 2 each significant report made to the Secretary pursu-
- ant to this Act during the reporting period.
- 4 (c) Public Availability.—Within 60 days after the
- 5 transmission of the annual report of the Office of Inde-
- 6 pendent Security Oversight under subsection (a), the Sec-
- 7 retary of Energy shall make copies of the unclassified por-
- 8 tions of such report available to the public upon request
- 9 and at a reasonable cost. Within 60 days after the trans-
- 10 mission of the annual report of the Secretary under sub-
- 11 section (b), the Secretary shall make the unclassified por-
- 12 tions of such report available to the public upon request
- 13 and at a reasonable cost.
- 14 (d) Special Reports.—The Director of the Office
- 15 of Independent Security Oversight shall report imme-
- 16 diately to the Secretary of Energy and the Congress when-
- 17 ever the Director becomes aware of particularly serious or
- 18 flagrant problems or deficiencies relating to the security
- 19 programs, practices, or operations of the Department of
- 20 Energy. The Secretary shall, within 7 calendar days after
- 21 receiving a report under this subsection, report to Con-
- 22 gress on the corrective actions taken to address such prob-
- 23 lems.
- 24 (e) Direct Reporting.—The Director of the Office
- 25 of Independent Security Oversight shall report directly to

- 1 the Congress with respect to those matters identified in
- 2 subsections (a) and (d), and the Secretary of Energy shall
- 3 not alter, modify, or otherwise change the substance of
- 4 any such report, nor shall the Secretary prevent, prohibit,
- 5 or delay any such report.
- 6 (f) Congressional Testimony and Briefings.—
- 7 The Director of the Office of Independent Security Over-
- 8 sight, whenever called to testify before any Committee of
- 9 Congress or to brief its Members or staff, shall provide
- 10 the Secretary of Energy with advance notice of the subject
- 11 matter of that testimony or briefing, but the Secretary
- 12 shall not alter, modify, or otherwise change the substance
- 13 of such testimony or briefing, or prevent, prohibit, or delay
- 14 such testimony or briefing.
