Strike all after the resolving clause and insert the following:

**1 SECTION 1. CONCURRENT RESOLUTION ON THE BUDGET
2 FOR FISCAL YEAR 2007.**

3 The Congress declares that this is the concurrent res-
4 olution on the budget for fiscal year 2007, including ap-
5 propriate budgetary levels for fiscal years 2008 through
6 2011.

16 **TITLE II—MISCELLANEOUS**
 17 **PROVISIONS**

18 **SEC. 201. PAY-AS-YOU-GO POINT OF ORDER IN THE HOUSE.**

19 (a) POINT OF ORDER.—It shall not be in order in
 20 the House to consider any direct spending or revenue leg-
 21 islation that would increase the on-budget deficit or cause
 22 an on-budget deficit for any of the following periods:

- 23 (1) The budget year.
- 24 (2) The period of the budget year and the next
- 25 4 fiscal years.



1 (b) ON-BUDGET DEFICIT.—

2 (1) DEFINITION.—For purposes of this section,
3 the term “on-budget deficit” means a budget deficit
4 that occurs in any year in which total outlays exceed
5 total revenues, counting Federal revenues and out-
6 lays, except those of the old age, survivors and dis-
7 ability insurance trust funds established under title
8 II of the Social Security Act, as provided in section
9 13301 of the Budget Enforcement Act of 1990.

10 (c) DETERMINATION OF BUDGET LEVELS.—For pur-
11 poses of this section, the levels of new budget authority,
12 outlays, and revenues for a fiscal year shall be determined
13 on the basis of estimates made by the Committee on the
14 Budget of the House.

15 (d) EXPIRATION.—This section shall expire on De-
16 cember 31, 2016.

17 **SEC. 202. DEPARTMENT OF DEFENSE REPORT TO CON-**
18 **GRESS.**

19 (a) FINDINGS.—The Congress finds that—

20 (1) \$290,600,000 has been specifically reallo-
21 cated to the Department of Defense in order to im-
22 plement the recommendations of the Government
23 Accountability Office (GAO) for improvement that
24 will produce tremendous cost savings within the De-
25 partment;



1 (2) between 2001 and 2005, GAO provided the
2 Department of Defense with 2153 recommendations,
3 many related to improving their business practices
4 and, to date, the Department of Defense has imple-
5 mented 604 recommendations and closed 96 rec-
6 ommendations without implementation; and

7 (3) the GAO estimates that the 604 imple-
8 mented recommendations have yielded the Depart-
9 ment of Defense a savings of \$40.8 billion between
10 fiscal years 2001 and 2005.

11 (b) ASSUMPTION; REPORT.—

12 (1) ASSUMPTION.—This resolution assumes
13 \$290,600,000 to be used by the Department of De-
14 fense to implement the remaining 1,453 rec-
15 ommendations of the Government Accountability Of-
16 fice.

17 (2) REPORT.—The Secretary of Defense shall
18 submit a report to Congress within 90 days that
19 demonstrates how each such recommendation shall
20 be implemented, and, in the case of any such rec-
21 ommendation that cannot be implemented, a detailed
22 reason for such inability to implement such rec-
23 ommendation.
