Ensuring Energy Independence For a Secure Future

Ensuring an independent, secure energy future demands that we make changes now. Renewable energy and energy efficient technology must be given the attention that they deserve.

As the Ranking Member on the Science Subcommittee on Energy, I successfully fought for an increase of \$177 million in the House Energy Bill for programs to support research and development of hydrogen, geothermal,

Representing the House Science Committee, I am part of a select group of congressional Members who will negotiate the differences between the House and Senate versions of the Energy Bill. I will fight to ensure that the bill retains the strong provisions I authored regarding renewable energy, energy conservation and expansion of alternative energy to meet the needs of Americans now and far

into the future.

Our security as a nation depends on our ability to break free of overseas oil resources. We must develop new sources of energy — such as hydrogen, geothermal, wind, solar and biomass to stop our dependence on dirty, exhaustible fossil fuels, and in that way we will provide a healthy, secure future for our children.

Lifelong **Social Security** for Women

The future of Social Security is on everyone's mind, but it is of particular concern to women. Women depend disproportionately on Social Security because we have traditionally been the caretakers in our society. We live longer and we make less money.

Social Security needs improvement, but the system is far from broken. Unfortunately, the Presidential Commission on Social Security suggests several changes that all include

Privatization of Social Security would be devastating to women and would risk the financial security of all retirees. That is why I am a co-sponsor of H.R. 4780, the "Rejection of Social Security Privatization Act of 2002." Private Social Security accounts cannot be relied on for lifelong security since they depend on the fluctuations of the stock market and we know for sure that Wall Street is no safe haven for future retirement income.

To provide security for senior citizens, we need a financially and structurally secure Social Security system that takes into account the reality of women's lives and provides a secure safety net for all retirees and the disabled.

Continuing the Fight for CEDAW

On May 13, I testified before the Senate Foreign Relations Committee for the ratification of the Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW). CEDAW is a United Nations treaty that serves as a powerful tool to provide a basic standard of human rights for women, so women can care for their families and provide for their children. It establishes a universal definition of discrimination against women and provides international standards to discourage such discrimina-

Since taking office in 1993, I have introduced a resolution in every Congress calling on the Senate to ratify CEDAW; the current resolution, H. Res. 18, has 119 bipartisan sponsors.

CEDAW has been ratified by 169 nations and over the past 20 years has become an important tool for nations to end human rights abuses of women and

girls-such as those committed by the Taliban in Afghanistan.

Women around the world suffer from violence, poverty and malnutrition. The root cause of this suffering is the discrimination that women face with regard to property rights, access to education, work opportunities and civil rights. The United States can help women all over the world by ratifying CEDAW.
