## Jobs and the Economy

Tince 2001, America's economy has lost more than 2.6 million jobs. Over 300,000 Ohioans are looking for work, and many have been looking six months or longer. The federal government is debating policies that will affect economic recovery in Ohio and throughout the nation.

#### **Reward Investments in America**

Congressman Brown supports the Job Protection Act,



which bases business tax benefits on U.S. production. With more than 170 bipartisan cosponsors, and endorsements by both the National Association of Manufacturers and

the AFL-CIO, the Job Protection Act is the right plan for U.S. manufacturers.

#### **Support Ohio Manufacturers**

The Manufacturing Extension Program (MEP) helped 2,700 Ohio companies improve their efficiency and save \$47 million in 2003. President Bush's budget maintains a 65% cut in MEP funding. Congressman Brown has called on House leadership to restore funding for MEP.

#### **Responsible Trade Policy**

President Bush is set to sign the Central American Free Trade Agreement (CAFTA) in May. CAFTA expands the failed policies of the North American Free Trade Agreement, which caused the United States to lose more than 500,000 jobs. Without proper labor and environmental standards, CAFTA will only

#### **Unemployment Extension**

Congress allowed extended unemployment to end last year. As a result, Ohio workers lost benefits that help their families make ends meet. Congressman Brown has cosponsored legislation to extend unemployment benefits.

## Medicare Prescription Drug Discount Card

Beginning May 3, Medicare beneficiaries can enroll in a drug discount card program. Some low income seniors are also eligible for up to \$600 toward prescription purchases. It is important to consider the benefits carefully before signing up for a card. Some cards may not cover the specific drugs you use. Covered drugs and discounts can change as often as once a week, and card sponsors do not have to notify you of these changes. You can learn more and compare prices of covered drugs at **www.medicare.gov** or by calling **1-800-MEDICARE (633-4227)**. Sponsors will advertise their cards in the media and by mail, but they cannot call or visit you. If you receive a call or visit offering a discount card, report this scam by calling **1-800-MEDICARE**.

## Medicare Forum

The new Medicare prescription drug law is confusing, and many Ohio seniors have questions about the new benefits. More than 100 area residents attended Congressman Brown's April informational forums in Akron and Lorain. Both events featured presentations from the health care advocacy organization Families USA, the Ohio Department of Insurance, and Ohio's Medicare contractor. ## President's Budget Threatens Akron Housing Programs

The budget submitted to Congress by President Bush contains drastic cuts to housing assistance and revitalization programs key to economic and community development in Akron.

The HOPE VI program, which provided nearly \$20 million to revitalize the Elizabeth Park Homes in Akron, received

zero funding in the Bush budget. In addition, drastic cuts were made to the Section 8 Housing Choice Voucher program, which provides rental assistance to thousands of Akron families. Congressman Brown pledged to fight these budget cuts, which threaten Akron's housing security.

If you have not registered to vote at your current address, you must register by October 4th to vote in the November 2nd general election. You can use the form on the opposite page to register. You do not need to complete items 7 or 8. For item 6, use your Social Security number or driver's license number. If you have neither, write "None" in 6. ## Veterans Update

Congressman Brown voted for an amendment to restore \$1.3 billion cut from the VA health care budget by the Republican House leadership. The Republican majority defeated that amendment and passed its plan instead.

The Bush administration budget for FY 2005 also inadequately funds veterans programs. It would raise health care costs for more than 500,000 veterans and impose new co-payments and enrollment fees costing veterans more than \$2 billion over five years. According to VA Secretary Anthony Principi, the President's budget is \$1.2 billion short of what the VA needs to adequately serve eligible veterans. Veterans organizations, including the VFW and Disabled American Veterans, issued strong statements criticizing this shortfall.

#### *Elyria Amtrak Service Restored*

n March, Amtrak reversed last year's decision to reduce passenger rail service to Lorain County. Brown had urged Amtrak officials to retain the Elyria stop of the Lake Shore Limited, which runs from Chicago through New York to Boston. Service resumed April 26th.
