

# Budget Shortfall

The Department of Veterans Affairs recently identified a staggering shortfall in veterans health care funding.

Congressman Brown joined more than 200 colleagues in calling for a \$1.3 billion Emergency Supplemental Spending bill to address this shortage. However, this legislation is just the first step.

The President's FY 2006 budget provides at least \$3 billion less

than veterans service organizations say is needed to meet the needs of our veterans. Over five years, the budget for veterans programs, primarily health care, is \$15 billion below the amount needed to maintain services at current levels. In 2006, the VA expects to treat 5.2 million veterans – double the number treated in 1995. And health care inflation is approximately seven percent a year.

Members have encouraged the President to submit budgets that more accurately reflect the needs of our veterans in the future.

Congressman Brown will continue working to ensure that veterans receive the health care and benefits they have earned.

## Helping Our Newest Veterans

Northeast Ohio has already witnessed the return of more than 2000 reservists and guard members who were deployed to Iraq or Afghanistan. Unfortunately, only about one-third of these new veterans have signed up for the benefits to which they are entitled. There are two important steps that all returning reservists and guard members should take. First, reservists and guard members are eligible for two years of Veterans Administration (VA) health care, but they must enroll to receive this benefit. Even if they generally use private physicians, they should be seen by VA doctors, who are trained to look for specific health

problems relating to combat. By identifying problems early it will be easier to document service connection and this could help with a future VA claim. To enroll in VA health care, call the VA at (877) 222-8387. In addition, reservists and guard members should be aware that they may be eligible for compensation for disabilities incurred or aggravated during active duty. To initiate the compensation process, call the VA at (800) 827-1000.
