## 3 SECTION 1. COMMERCIAL SPACE LAUNCHES.

- (a) APPLICATIONS.—Section 70105(a) of title 49,
- United States Code, is amended— 5
  - (1) in paragraph (1) by striking "subsection (b)(2)(D)" each place it appears and inserting "subsection (b)(2)(E)"; and

 following:

3 "(2) In carrying out paragraph (1), the Secretary 4 shall ensure that each license approved includes minimum 5 standards to protect the health and safety of crews and 6 space flight participants, taking into account the inher-7 ently risky nature of human flight.

8 "(3) In carrying out paragraph (1), the Secretary 9 may establish procedures for safety approvals of launch 10 vehicles, reentry vehicles, safety systems, processes, serv-11 ices, or personnel that may be used in conducting licensed 12 commercial space launch or reentry activities.".
