Dear Chairmen Specter and Regula and Ranking Members Harkin and Obey:

As you prepare to go to conference on the Fiscal Year 2006 Labor, Health and Human Services, and Education Appropriations bill, we write to urge you to increase funding for the highly successful Low Income Home Energy Assistance Program (LIHEAP) to \$4 billion. As the nation faces an unprecedented and unexpected surge in home energy prices due in part to the devastating tragedy of Hurricane Katrina, it is critical that the level of funding provided for this program be revisited in light of the new circumstances.

While we must fully address the exceptional circumstances of those directly affected by Hurricane Katrina, we must also address the impacts this disaster will have on heating and air conditioning prices across the country this winter and next summer. Low-income families across the nation, already struggling to pay their heating and air conditioning bills at current prices, face dramatically increased bills over the next year as a result of this disaster.

According to a report released on September 7 by the Department of Energy's Energy Information Association, for all of 2005, the DOE estimates that energy expenditures in the United States will be \$1.03 trillion, approximately 18 percent above the 2004 level. The DOE predicts residential per-household expenditures for fuels this winter to increase 71 percent for natural gas, 17 percent for electricity, 31 percent for heating oil, and 40 percent for propane compared to last winter.

Without LIHEAP, millions of senior citizens on fixed incomes, working families with children, and persons with disabilities from one end of the country to the next would be

forced to choose between heating their homes and putting food on the table. In the richest country in the world, no one should ever have to make that unacceptable choice.

Since the winter heating season of 2001-02, the price of heating oil increased from \$637 to \$1261, natural gas from \$602 to \$954 and propane from \$888 to \$1377 – and that was before the increase in prices expected from Hurricane Katrina. Meanwhile, the average LIHEAP recipient in 2005 receives a mere \$318 in assistance, and only 15% of the 32 million Americans eligible to receive LIHEAP funding actually receive it.

The Energy Information Administration predictions released on September 7 show that prices for winter fuel oil, propane and natural gas will be 218% higher this year than in 2001, when LIHEAP was funded at \$2.25 billion. Simply maintaining LIHEAP's FY 2001 purchasing power would require an appropriation of \$4.9 billion in FY 2006.

Of course, the incomes of households in the lowest income brackets have not risen commensurately over the same period and further hundreds of thousands of families became eligible last year by virtue of falling into poverty. In FY 2005, many households exhausted all benefits by the second month of their participation because the program's purchasing power had shrunk so far below its previous value. And there is no way of telling how many newly-poor consumers will be seeking assistance in the wake of their displacement by hurricane Katrina.


The Energy Policy Act signed just two months ago by President Bush increased the LIHEAP authorization from \$2 billion to \$5.1 billion. An FY 2006 appropriation of \$4 billion would still be \$1.1 billion below the level authorized. Coupled with any additional LIHEAP funding provided in an emergency supplemental, a \$4 billion FY 2006 appropriation for LIHEAP would provide more meaningful assistance to those already participating in the program and would help thousands of low-income Americans, the elderly and disabled keep from freezing this winter or overheating next summer.

We appreciate your consideration of this important request.


