
CREDIBILITY GAP: BUSH AND PORT SECURITY

With President Bush on Monday touting port security, his rhetoric is running up against contrary reality. Specifically, while the Coast Guard has said that there are almost \$1 billion in port security needs, and while the Customs Service has urgently requested \$67 million for the Container Security Initiative, Bush has refused for more than a year to request any money for these purposes. Today, Congress has only funded \$400 million for port security grants, and only \$22 million (or 32% of what is necessary) for the Container Security Initiative.

"We're working hard to make sure your job is easier, that the port is safer. The Customs Service is working with overseas ports and shippers to improve its knowledge of container shipments, assessing risk so that we have a better feel of who we ought to look at, what we ought to worry about." – Bush, 6/24/2002

Bush's FY2003 budget proposal provided <u>zero for port security grants</u>. Additionally, his budget <u>included no money for the Container Security Initiative</u>, which the Administration's own Customs Service said needed approximately \$67 million.



Bush vetoes money for port security [8/13/02]

On August 26th, 2002, the Bushappointed U.S. Customs Commissioner told Congress that the Container Security Initiative was at "the forefront of our government's effort to secure the Nation from the potential terrorist threat using cargo containers" adding that it is "a major piece of the President's National Strategy for Homeland Security."

Unfortunately, on August 13th, **Bush actually vetoed \$39 million for the Container Security Initiative** passed on a bipartisan basis by Congress. Upon his veto, Bush said, "At the end of the session, Congress sent along more than \$5 billion in extra spending I didn't ask for...I made my opposition clear. We were pretty plain-spoken about the supplemental...I understand their position, and today, they're going to learn mine. We'll spend none of it."[8/13/2002]

Just a week after this speech, Bush submitted his 2004 budget that once again included **no money for port security grants.** This budget decision came just two months after the Coast Guard's December report indicating that the first year cost of port security is at least \$963 million and that total costs over the next decade are \$4.4 billion.

Amazingly, Bush's supplemental request once again included <u>no money for port security grants</u> <u>or the Container Security Initiative</u>.
