### **Bush Budget Cuts Grants and Training to Prepare for Emergencies by \$612 Million**

Ignores Lessons From Katrina, Terrorist Threats

WASHINGTON – Today, George W. Foresman, Undersecretary for Preparedness at the Department of Homeland Security, testified on the President's FY 2007 budget request. Foresman oversees the Department of Homeland Security's <u>Preparedness Directorate</u>, which funds anti-terrorism grants and coordinates activities to protect our borders, seaports, bridges, highways, and critical information systems.

The Bush budget proposes cutting preparedness grants and training in the directorate by \$612 million below last year. These programs have already been cut by over \$1 billion since 2004.

These cuts ignore the lessons of Hurricane Katrina and the analysis done since September 11<sup>th</sup>. The <u>2003 Rudman Report</u> found that first responders were "drastically underfunded" and "dangerously unprepared." The report estimated "additional funding required to cover potential emergency responder needs is approximately \$98.4 billion over five years." Despite these dire warnings, the Bush budget would cut funding for preparedness grants.

- The president would eliminate \$851 million for seven preparedness grant programs and replace them with \$600 million in "Targeted Infrastructure Grants," a 30% cut. This includes grants to protect ports, rail, transit, trucking and intercity buses as well as state law enforcement protection grants.
- Bush would cut funding for fire fighters by \$355 million, or 55%. Fire fighter grants were already cut by \$98 million from 2004 to 2006. These cuts ignore warnings in a 2003 report by the U.S. Fire Administration which found that fire stations across the country are under staffed, under trained, and under equipped.
- Training grants are cut by \$128 million, or 41%, even though the <u>White House Katrina report</u> notes that "the Department of Homeland Security should develop a comprehensive program for the development and education of the Nation's homeland security personnel" including all levels of government and private & charitable organizations.

These cuts are compounded by the \$1.3 billion in cuts to Department of Justice state and local law enforcement grants proposed in the Bush budget. These grants have already been cut by \$1 billion since 2001.
