NOTE: This analysis does not look at the funding suggested for the separate functional categories. For discretionary spending, the Appropriations Committee is not bound by the functional suggestions in the Budget Resolution. For mandatory spending, only reconciliation proposals to change existing law or the relevant Committee Allocation (302(a) allocation) made in accompanying Committee Report are of real relevance. Many budget reform proposals have

suggested eliminating most of the functions. The RSC Budget only includes the following function categories: Defense, Homeland Security, Interest, Offsetting Receipts and Allowances (which includes all other spending). Because of this change, even if functional totals were relevant, it would be impossible to compare functional categories for all five proposals.

<u>Democrat Leadership:</u>

- Reconciliation instructions to reduce Medicare payments to providers under the Medicare Advantage Program and increase the value of the Medicare drug benefit
- Instructions to the Armed Services Committee to find \$2 billion in annual discretionary savings. The savings are to be used to eliminate the Social Security offset to the Military Survivor Benefit Plan
- Reserve fund of \$7.6 billion over ten years for the Family Opportunity Act
- Reserve fund of \$1.115 billion over ten years for S-CHIP

- Reserve fund of \$3.5 billion over ten years for Transitional Medicaid Assistance
- Deficit-neutral reserve fund for Health Insurance for the Uninsured
- Contingency procedure for Surface Transportation

Enforcement Provisions:

Committee Budget:

- Restriction on advanced appropriations
- Requires spending designated as an emergency to meet the criteria for emergency spending

<u>Democratic Leadership:</u>

• Establishes a "paygo" rule for new mandatory spending or tax legislation.

RSC:

- Restriction on advanced appropriations
- Requires spending designated as an emergency to meet the criteria for emergency spending. This provision is enforced via a point of order, and if the point of order is waived, a point of order lies against the rule waiving the point of order.
- Firewall preventing the consideration of Appropriations bills unless at least \$402 billion is provided for Defense and Military Construction
- Point of order against exceeding the spending limits established by the Budget Resolution (via 302(a) allocations). If the point of order is waived in a rule, then a point of order lies against the rule. This provision essentially requires a separate vote of the House to violate the Budget totals.
- Requires that prior to consideration of any Appropriations bill, the House and Senate Appropriations Committees agree on an initial set of 302(b) subcommittee allocations. While the House and Senate may change their allocations at any time, this provision ensures that both chambers start at the same place.
- Prohibition on using general tax increases to offset new spending in an effort to comply with the Budget Resolution.

Blue Dogs:

- Restriction on advanced appropriations
- Point of order against legislation increasing the deficit after fiscal year 2009

- Creates discretionary spending caps for fiscal years 2005 through 2007 enforceable via a point of order. If a rule waives the point of order, then a point of order lies against the rule.
- Includes a definition of emergency spending, requires a justification for emergency spending, and permits votes in the House to remove emergency designations.
- Establishes a "paygo" rule for new mandatory spending or tax legislation. Any rule waiving the "paygo" rule would be subject to a point of order.

RSC:

- Allows for tax cut levels to be increased to take into account the economic feedback from lower taxes based on realistic (dynamic) scoring
- Family Budget Protection Accounts permit Members to credit the savings from amendments to both discretionary and mandatory spending bills to deficit reduction

Democratic Leadership:

Blue Dogs:

- Requires Committee Reports to include disclosure information about the impact of the bill on the public debt
- Requires that Committee Reports accompanying spending and tax bills include an estimate of the interest costs of the legislation
- Requires that if dynamic scoring is used for tax cuts, a study also be conducted on the economic effects of any increase in the deficit caused by the tax proposal.
- Permits a \$150 billion increase in the statutory debt, after which time increases are limited to \$100 billion (enforced via a point of order), unless there is a certification that the budget will be balanced by 2012
- Includes a review of the budget outlook to determine if we are expected to achieve a balanced budget
