## The Budget Resolution Conference Report Cuts Funding for Veterans' Health Care by \$13.5 Billion Over 5 Years

Dear Democratic Colleague:

Last week, Republicans on the House floor denied that their budget cut funding for veterans' appropriated health care. Though their budget just barely keeps pace with inflation for 2006, it cuts funding below that level in every subsequent year. Over five years, the Republican conference report on the budget resolution cuts veterans' health care funding \$13.5 billion below what the Congressional Budget Office (CBO) estimates is needed to maintain services at their current levels.

Each March, CBO issues its official ten-year budget forecast that projects spending at the current level – adjusted solely for inflation – and thus estimates future budget deficits or surpluses. This "baseline" for appropriations for veterans' health care incorporates an average 2.9 percent annual rate of inflation, which is probably too low given rapidly escalating health care costs. In recent years, private health care spending per capita has increased an average 6.5 percent per year and private health care insurance premiums increased even more. The baseline does not include any non-inflationary factors contributing to rising costs such as increased enrollment or the increase in the average age of patients.

This baseline excluding supplemental funding is CBO's conservative estimate of what we will need just to maintain our current level of veterans' health care services. These March baseline numbers are on the attached page from CBO and are displayed in the table above. They show that the funding in the conference report on the budget resolution is \$13.5 billion less than needed to maintain purchasing power over the next five years.
