Does your business have a prototype that can help secure our nation's land and sea ports of entry? Do you develop technology that can assist first responders in a crisis?

Your business's innovation and creativity could be used by the DHS Homeland Security Advanced Research Projects Agency (HSARPA). DHS HSARPA administers a Small Business Innovation Research Program (SBIR). The goal of SBIR is to increase the participation of small businesses in research and development programs and to challenge industry to bring innovative homeland security solutions to reality. SBIR will be releasing a solicitation later this spring.

Another source of information for solicitations is the HSARPA solutions portal. The HSARPA solutions portal provides businesses and agencies with a list of solicitations for long range science and technology projects that can be conducive to the DHS Directorate for Science and Technology (S&T), the primary research and development arm of DHS. Due to the technological requirements of the solicitations, white papers are mandatory in most instances. Like SBIR announcements, paper copies of these announcements are not issued and may be found by visiting the S&T Broad Agency Announcement (BAA) website at www.hsarpabaa.com.

DHS also welcomes unsolicited proposals for truly innovative and unique solutions. Please visit part 15.6 of the Federal Acquisition Regulation, <a href="http://www.acquisition.gov/far/current/html/Subpart%2015\_6.html">http://www.acquisition.gov/far/current/html/Subpart%2015\_6.html</a>, which outlines the specific criteria which must be met before an unsolicited proposal can be submitted. Minority Business Enterprise Centers (MBECs), Native American Business Enterprise Centers (NABECs), and Business Resource Centers (BRCs) provide individualized management and technical assistance to minority entrepreneurs at every stage of business development. Minority Business Opportunity Committees (MBOCs) coordinate Federal, state and local business resources. They are designed to identify business opportunities and leverage existing programs to increase market access for minority-owned firms.
