This project addresses the development of advanced sea surveillance radar for Future Naval Capabilities. This project is the development of a lightweight, high performance, affordable moving target indication (MTI) radar for Navy Vertical Take Off Unmanned Air Vehical (VTUAV) aircraft. The U.S. Navy plans to use the VTUAV aircraft as an organic surveillance asset for the new Littoral Combat Ship (LCS),

The project plan supplements work being funded by the Office of Naval Research. The new activity adds needed imaging modes to the MTI Scout Radar for threat classification. The plan spans a 1 year period and requires \$4.6M of additional funding.

This project will improve national security by supporting Office of Navy Research efforts to solve the problem of using Unmanned Air Vehicles to detect, identify, and defeat attack from hostile small fast boats. This MTI Scout Radar will now solve that problem. The problem is that existing radars with comparable performance far outweigh the payload capacity of the Fire Scout helicopter and are much more expensive than the MTI Scout Radar.

This project provides jobs for constituents of the 26th District of Texas in the development and production of the MTI Scout Radar.

2. Please explain why this project should be considered a priority:

Recent events off the coast of Iran have exposed the vulnerability of US Navy ships and sailors to surprise attack by swarming small boats. This level of asymmetric attack will only increase as the Littoral Combat Ship (LCS) is deployed for operation in hostile littoral environments utilizing VTUAVs (Fire Scout) for

surveillance. Currently, the Fire Scout utilizes a short range electro-optical sensor for target detection and identification but with future plans for a search radar capability. Operational analysis has indicated the need for additional VTUAV radar capabilities beyond its currently planned target tracking capability. This MTI Scout radar enhancement request addresses short range Navy surveillance and engagement limitations by adding additional capabilities for radar imaging and threat identification.
