McKeon Rejects Democrat Tax & Spend Budget

An analysis by House Budget Committee Republicans found that the Democrats' FY 2009 budget imposes a \$683 billion tax increase, increases non-security spending by \$23.4 billion over and above the President's request, and allows the unfunded liability in Social Security and Medicare to grow by \$14 trillion.

McKeon argues that these policies of federal fiscal heavy-handedness stifle innovation and hamper job growth. Rather than supporting more bloated federal bureaucracy, Congress should be focusing on proven programs to support students, workers, and families without driving up taxes and ignoring the **entitlement crisis**.

With this budget, Democrats call for the largest tax increase in American history on families already struggling with cost of living increases, higher college tuitions, increased gas prices, and rising healthcare costs. Read more...

The California Court of Appeal for the Second Appellate District in Los Angeles has agreed to rehear the case of *In re Rachel L.*, which declared most forms of **homeschooling** unlawful in California.

The decision, handed down in late February, was decried by McKeon, Governor Schwarzenegger, key Republicans, and numerous parental rights advocates. Republicans are closely monitoring the case and its implications for homeschooling nationwide.

Republicans Decry Reversal of Mine Safety Reforms

Over the strong objections of Republicans, academic leading experts, and the mining community, the House narrowly passed a bill early this year that rewrites major mine safety legislation approved less than two years ago. Republicans objected to the S-MINER Act (H.R. 2768) because it halts the progress of bipartisan reforms enacted in 2006 and threatens miners' jobs through onerous new regulations and unfunded mandates on the mining industry.
