AMENDMENT TO H.R. 4137 OFFERED BY MR. HOEKSTRA OF MICHIGAN

Title VI accountability

In section 601(a) of the bill, strike "and" at the end of paragraph (2), strike the period at the end of paragraph (3) and insert "; and" and add at the end the following new paragraph:

- 3 "(d) Consultation.—The Secretary shall, prior to
- 4 requesting applications for funding under this title during
- 5 each grant cycle, consult with and receive recommenda-
- 6 tions regarding national need for expertise in foreign lan-
- 7 guages and world regions from the head officials of a wide
- 8 range of Federal agencies, including Department of Com-
- 9 merce, Department of Defense, Department of State, Of-
- 10 fice of the Director of National Intelligence, and National
- 11 Security Agency. Such agencies shall provide information
- 12 to the Secretary regarding how the agencies utilize exper-
- 13 tise and resources provided by grantees under this title.
- 14 The Secretary shall take into account such recommenda-
- 15 tions and information when requesting applications for

- 1 funding under this title, and shall make available to appli-
- 2 cants a list of areas identified as areas of national need.
- 3 "(e) Survey.—The Secretary shall assist grantees in
- 4 developing a survey to administer to students who have
- 5 participated in programs under this title to determine
- 6 postgraduation placement. All grantees, where applicable,
- 7 shall administer such survey not less often than annually
- 8 and report such data to the Secretary.".

In section 601(b) of the bill, strike "and" at the end of paragraph (2), strike the period at the end of paragraph (3) and insert "; and" and add at the end the following new paragraph:

- 9 (4) by adding at the end the following new sub-
- 10 section:
- 11 "(e) APPLICATION.—Each institution or combination
- 12 of institutions desiring a grant under this section shall
- 13 submit an application to the Secretary at such time, in
- 14 such manner, and accompanied by such information and
- 15 assurances as the Secretary may require. Each application
- 16 shall include an explanation of how the activities funded
- 17 by the grant will reflect diverse perspectives and a wide
- 18 range of views and generate debate on world regions and
- 19 international affairs. Each application shall also describe
- 20 how the applicant will address disputes regarding whether
- 21 activities funded under the application reflect diverse per-

- 1 spectives and a wide range of views. Each application shall
- 2 also include a description of how the applicant will encour-
- 3 age government service in areas of national need, as iden-
- 4 tified by the Secretary, as well as in needs in the edu-
- 5 cation, business, and nonprofit sectors.".

Section 601(h)(2) of the bill is amended to read as follows:

6 (2) by adding at the end the following new sen-7 tences: "In keeping with the purposes of this part, 8 the Secretary shall take into account the degree to 9 which activities of centers, programs, and fellowships 10 at institutions of higher education advance national 11 needs, generate and disseminate information, and foster debate on international issues from diverse 12 perspectives. 'The Secretary shall also consider an 13 applicant's record of placing students into service in 14 areas of national need and an applicant's stated ef-15 forts to increase the number of such students that 16 17 go into such service.".

After section 606 of the bill, insert the following new sections (and redesignate the succeeding section accordingly):

- 13 a plan to address those needs. The report shall be provided

- 18 "Each institution of higher education that receives a
- 19 grant under this title shall assure that—

- of those students for the purpose of recruiting for
- 25 graduate opportunities or prospective employment;
