DO-NOTHING REPUBLICANS RETURN TO WASHINGTON TO DO NOTHING

Republicans return from their second Spring Break this year divided and unable to make progress on important issues: record-setting prices at the pump, a spiraling culture of corruption, skyrocketing health care costs, a dangerous energy crisis, a complicated immigration debate and an exploding national deficit and debt.

A Do-Nothing Congress: The Numbers Tell the Story

- The "Do-Nothing" Congress of 1948 met for 108 days. The 109th Congress is scheduled to meet for 97 voting days.
- Congress met for the fewest number of days in January and February since 1975, took the first St. Patrick's Day recess since 1947 in March, and failed to pass a House budget resolution before the Spring Recess in April.
- April 25th marks only the 22nd Voting Day of the 109th Congress, 2nd Session. And, there are only 55 days scheduled in session between now and Labor Day.

What's Not Getting Done by the Do-Nothing Republican Congress

- **TERRORISM:** Osama Bin Laden remains at large, nearly five years after the attacks of September 11th. Many of the recommendations of the bipartisan 9/11 Commission have not been implemented.
- <u>IMMIGRATION:</u> Comprehensive reform to deal with 11 million illegal immigrants is mired down by Republican in-fighting and Republican insistence on criminalizing undocumented workers.
- **GAS PRICES:** The nationwide average price of gasoline is nearly 70 cents higher than it was one year ago and Republicans have done little in the short or long-term to lower prices or promote alternative energy sources.
- **GOP CORRUPTION:** Republicans are set to vote on a bill in the House this week that is widely viewed as doing nothing to rein in the Republican culture of corruption.
- <u>TAX REFORM:</u> Nearly 20,000 pages have been added to the tax code under President Bush and the Republican Congress, who have refused to address this issue.
- **WAGES:** Average household income is down by \$1,670 (during President Bush's first term), while in 2005 alone, the median compensation of CEOs of the 100 largest U.S. companies soared 25% to nearly \$18 million.
- MINIMUM WAGE: Republicans continue to refuse to raise the minimum wage, which has not been increased since 1997.
- **HEALTH CARE:** Since 2000, the cost of health insurance has risen by 59 percent, while workers' wages have increased by 12 percent.
- **DEBT AND DEFICIT:** After inheriting record budget surpluses, Washington Republicans have instigated an historic fiscal turnaround adding \$3 trillion to the national debt and presiding over record budget deficits. Republicans doubt they will be able to pass a budget blueprint this year, which could be a key step in reining in their out-of-control deficits.
