H. R. 648 Elimination of House Floor Privileges Passes

This legislation is designed to ensure that former Members of Congress who are registered lobbyists do not receive preferential treatment or consideration or access to current Members of the United States House of Representatives. This bill eliminates floor privileges and access to Member exercise facilities for registered lobbyists who are former Members or officers of the House. I voted in support of this measure that passed by a vote of 379 to 50.

H. Res. 653 Budget Reconciliation Bill Passes

This bill attempts to reduce the federal deficit by cutting \$39 billion from critical programs affecting the health, education, and welfare of American citizens. It cuts Medicaid by \$6.9 billion over five years and \$28.3 billion over 10 years. It also cuts Medicare by \$6.4 billion. It also decreases the funds allocated to commodity, conservation, and rural development

through the Farm Bill by \$2.7 billion. legislation reduces spending on student programs by \$12.7 billion over four increases student loan interest rate caps loan taxes and fees. It places billions of student aid at risk by cutting \$2.2 billion

funds used to administer student aid programs. This legislation also cuts \$1.6 billion from child support programs over five years. Custodial parents will receive \$2.9 billion less child support over five years and \$8.4 billion less over 10 years. The report cuts \$577 million from foster care programs by reducing the number of children eligible for foster care. It also raises \$553 million by increasing fees citizens must pay to file for bankruptcy or for civil case filing. Voted against this bill, which passed by a vote of 216 to 214.

H. R. 4659 USA Patriot Act Amendment Passes

This bill amends the USA Patriot Act by extending the sunset of certain provisions included in original legislation. Some conditions scheduled to expire on February 3 are now scheduled to end on March 10, 2006. For example, this bill requires high-level approval by either the FBI Director, Deputy Director, or Executive Assistant Director for requests for certain records, including library records, medical records, educational records, and tax return records. It also limits retention, and prohibits dissemination, of information concerning U.S. persons. It also requires a description of a specific target in both the application and court order for "roving wiretaps," and specific facts in the application that show that the target's action may thwart surveillance efforts—if the target's true identity is known. This measure passed the House by a voice vote.

H. Res. 655 Resolution Honoring Coretta Scott King Passes

This bill honors the life of Mrs. Coretta Scott King and recognizes her accomplishments and contributions as a leader in the struggle for civil rights. I co-sponsored this bill, which passed the House by a voice vote.
