


Laying Tracks To Abraham Lincoln National Airport

Dear Neighbor:

I am very pleased to announce two new transportation projects that will provide new commuter train service to our communities in the foreseeable future.

First, Metra's new SouthEast Service (SES) will run from Crete to Chicago's LaSalle Street Station along existing Union Pacific/CSX tracks. With potential stops in Dolton, South Holland, Thornton, Glenwood, Chicago Heights, South Chicago Heights and Steger, the new SES will connect the South Side and south suburbs to Downtown

Chicago and beyond.

Second, CTA's Red Line will be extended from 95th/Dan Ryan to 130th Street/Stony Island Avenue. With new stations, the Red Line Extension will serve more densely populated neighborhoods, link to a major automobile factory and relieve bus

Thanks to the new and extended train lines, our communities will become linked to the entire regional mass transit network. The SES and Red Line Extension will help reduce commute times, improve quality of life, strengthen our communities and unify the region.

I am pleased that I was able to include the SES and the Red Line Extension in the massive \$286.4 billion surface transportation bill -- the Transportation Equity Act that was approved by Congress in July and signed by the President in August. As an authorized project in the bill, the SES and Red Line Extension are eligible to receive hundreds of millions of dollars in federal funding over the next six years.

The SES and Red Line Extension are huge, multi-jurisdictional, multi-million dollar projects that will take years to complete. I will continue to work with local, state and federal elected and transportation officials to ensure that our communities are properly served.

Now that the SES and Red Line Extension have been signed into law, major tracks have been laid. Through diligence, perseverance and hard work, new trains will be coming to the South Side and south suburbs. Onward we go!
