Secured Projects by Congressman Bill Shuster in FY 2008 Appropriations Bills

Every year, Congress drafts a budget that outlines how much will be spent to fund the Department of Defense, the Department of Health and Human Services and other important federal agencies. Once this outline is set, it is up to Congress to then set specific funding levels within those agencies through the appropriations process.

As a fiscal conservative, I believe that government spends too much and is far to free with the hard earned dollars our taxpayers must pay every April to keep their government open and operating. I am dedicated to reducing the size of the budgetary "pie" that is carved up and spent and I oppose programs and projects that embody waste, inefficiency and quintessential "red tape."

However, one of my most important responsibilities as your representative in Congress is to ensure the 9th district gets the money it needs from the federal government to fund important projects to improve our infrastructure, boost economic investment, create jobs and offer a better standard of living the residents of central and western Pennsylvania. One of the most direct ways I can accomplish this is through Member directed spending, commonly called "earmarks." It is important to note that earmarks make up less than one percent of the federal budget.

I believe that taxpayer money is best spent by subjecting programs to public debate and open scrutiny by Congress. Allowing Members of Congress to fight for their constituents' interests and echo their concerns to the committee chairmen who control the government's purse strings is an important aspect of our representative form of government. The alternative of empowering nameless, faceless government bureaucrats in Washington to spend your money when they haven't been to the 9th district let alone understand its needs is the opposite of accountability and encourages fraud and abuse.

That being said, Congress must be responsible and transparent with its spending practices. Disclosure is important and projects must stand up to public scrutiny. For that reason, I have attached a spreadsheet of projects that up to this point I have secured in the committees of the House that handle the appropriations process.

It is important to note that these projects have not gone through all of the steps necessary to make them law. Instead, these requests have only been secured by the committees that have jurisdiction over their respective federal agencies. In other words, just because a project appears on this list, it is not a clear sign of success. Success is only certain when the legislation is signed into law by the President.

Currently, the spending bills in the House of Representatives must be reconciled with the bills passed by the Senate, and then signed into law by the President before they become law and any funding is released. Many changes occur in these bills each year before they become law, and this list will be updated as the appropriations process goes forward.
