

#### <u>INSTRUCTIONS FOR CANDIDATES</u> SEEKING NOMINATIONS TO SERVICE ACADEMIES

Individuals seeking nomination to one of the service academies from Congressman Davis, 4<sup>th</sup> Congressional District of Tennessee, are encouraged to apply in the spring of their junior year. Only students eligible to enter an academy in the summer of 2009 (Class of 2013) may apply for nomination at this time. Submit the following information to:

- 1. Completed "Application for Nomination to United States Service Academies"
- 2. Copy of birth certificate
- 3. **OFFICIAL** SAT or ACT scores (must be from testing agency itself)
- 4. **OFFICIAL** high school transcript, class rank (sent by your guidance office) and college transcript (if applicable)
- 5. Resume of extracurricular activities. It is very important to be thorough and include all information for each year in high school. Include both school related and outside activities (note leadership positions held); athletic activities (note varsity letters earned and leadership positions held); scholastic honors; list any part-time or full-time jobs you have held since you have been in high school. (please type)
- 6. Recent photograph
- 7. Personal statement addressed to Congressman Davis stating what motivates him or her to attend a United States Service Academy. (One page typed is sufficient)
- 8. **Maximum** of three letters of recommendation (<u>one must be from a school official</u>). Give each recommender an "Instructions for Recommender" sheet.
- 9. You may also attach a brief explanation of any extraordinary or unusual personal or family circumstances that you think should be taken into consideration.

#### **Eligibility**

Nominees to the service academies must be United States citizens and applicants to Congressman Davis' office must be permanent residents of Tennessee' 4<sup>th</sup> Congressional District. Candidates must be at least 17 years old and not 23 years old by July 1 of the year of admission. Candidates must be unmarried, not pregnant, and have no legal obligation to support any dependents. These stipulations have been established by the service academies.

<u>Prior to applying for a nomination, each candidate must contact the academies directly to request a Pre-Candidate Questionnaire.</u> Upon the completion and return of this form to the academy, you will be informed of academy requirements, such as medical examinations and physical aptitude tests. It is also recommended that each candidate attempt to visit the academies to meet with admissions representatives, talk to cadets and view the facilities.

#### **DODMERB**

All academies require you pass a Department of Defense Medical Examination Review Board (DODMERB). Candidates who meet the minimum scholastic standards will be scheduled to take a service academy qualifying medical examination. The academy to which you have applied will initiate the scheduling of the exam; once taken the results may be used for all service academies. Candidates who have questions about their medical exam results should direct them to: DODMERB

Medical Scheduling and evaluation are time-consuming processes, especially if consultation, retesting, or corrective action is required. The process may take from six weeks to four months.

#### **Method of Nomination**

The law pertaining to congressional nominations stipulates that each Member of Congress is allowed a maximum of five "charges" at each academy in any given year (Merchant Marine is an exception). When a "charge" graduates, a vacancy is created that the member may fill. Each member nominates a slate of ten (10) candidates for each vacancy. Congressman Davis uses a "competitive" form of nomination. Using this method, the Member of Congress submits to the academy an unranked list nominees for each vacancy. The academy then reviews the list and selects the most fully qualified candidate. This candidate becomes the member's "charge". The remaining nominees are then considered and may also be offered appointments, but they will not be the member's "charge".

Due to the competitiveness of the selection process, it is strongly recommended that each candidate apply to both U.S. Senators, their U.S. Representative and the Vice President.

If an applicant has a parent who is an active or retired military person, a disabled or deceased veteran, a POW/MIA, or a Medal of Honor winner, the candidate may be able to apply for a Presidential nomination through the military or other form of nomination. For further information, please refer to the academy catalog or speak to an admissions representative or liaison officer.

#### **Additional Information**

- Congressional nomination does not guarantee acceptance to the service academies, but only assures that your application will be considered first by the review boards. Your application to each academy that you are considering should be completed during or before the first semester of your senior year.
- Academically, the majority of students accepted to the academies are in at least the top 20% of their class, with higher than average test scores.
- Most students who receive appointment offers are active at school and in their community and hold leadership roles in sports and other extracurricular activities.
- Acceptance of an offer of appointment from an academy obligates you to at least a nine-year commitment, four years at the academy and five years of active duty service. Serving in the military means that you may be faced with the possibility of a combat situation. If you are just looking for a great education and great job skills, apply to a college or university. If at anytime you are uncomfortable about the military commitment, you are free to back out of the process at anytime.

## <u>Instructions—Letters of Recommendation for</u> United States Service Academy—Application for Nomination

**Candidate:** Please give a copy of this sheet to the three people who agree to write a letter of recommendation for you.

**Recommender:** This student has expressed desire to attend a United States Service Academy (i.e. Military Academy at West Point, Naval Academy at Annapolis or the Air Force Academy). Admission to these academies is extremely limited, highly competitive and an appointment is an esteemed honor and achievement. After successfully completing a rigorous four-year program in one of these competitive schools and receiving a first rate education, a successful graduate will be pledged to serve a term as an officer in our armed forces.

In order to apply to a service academy, an applicant must obtain a nomination from an authorized source, and this applicant has requested a nomination from Congressman Lincoln Davis, Representative of the Fourth District of Tennessee. Congressman Davis and his Academy Selection Committee would appreciate your thorough and honest evaluation of applicant's fitness for U.S. Service Academy admission and ensuing military career. The academies consider evidence of character, scholarship, leadership, physical aptitude (athletic ability), medical fitness, goals and motivation in determining each applicant's "whole person" evaluation.

Congressman Davis, his staff and his Academy Selection Committee will hold your comments in the strictest confidence. Thank you and we appreciate your assistance.
