A comprehensive national approach to climate change will be most effective when all levels of government – Federal, State, Tribal and local – play active roles. Determining these roles will require balancing a number of considerations while recognizing the unique nature of this global environmental challenge and the need to use our resources efficiently. The attached White Paper discusses key factors for consideration by the Committee in determining what roles are appropriate for each level of government as part of a comprehensive, national approach to addressing climate change.
