DNS Developments Feed Growing Cybersquatting Concerns (www.wipo.int - 3/27/08)

Against the background of an unprecedented number of cybersquatting cases in



2007, the evolving nature of the domain name registration system (DNS) is causing growing concern for trademark owners around the world. Last year, a record 2,156 complaints alleging cybersquatting - or the abusive registration of trademarks on the Internet - were filed with the World Intellectual Property Organization's (WIPO) Arbitration and Mediation Center (Center), representing an 18% increase over 2006 and a 48% increase over 2005 in the number of generic and country code Top Level Domain (gTLDs and ccTLDs) disputes.

Newton woman's mission: Protecting property from eminent domain By Stephen J. Novak (New Jersey Herald-3/30/08)

Connie Sutton's Hicks Avenue home was among the 26 houses originally included in a plan to redevelop one of three areas in Newton. It was her fear that the town would take her home through a legal process known as "eminent domain" that she began attending Planning Board hearings, appealing to local officials to have her home and others removed from the plan.

Sutton and others succeeded in having their homes removed from the plan after hearings in December. But after meeting other residents who shared her concerns, Sutton decided to continue attending hearings for the proposed Railroad District redevelopment area around Diller Avenue, and she helped found the grassroots organization Derail Abusive Redevelopment in Newton.

MISMO & PRIA Publish IP Property Rights Disclosure Draft (dsnews.com 3/28/08)

Intellectual property rights assistance center set up in Shanghai (People's Daily Online-3/28/08)

In recent years, Shanghai's intellectual property (IP) rights cases, especially IP rights cases related to foreigners, have been on the rise. In order to provide the necessary advisory services and specialized assistance to the IP rights obligee and other parties, the Shanghai Intellectual Property Assistance Center formally opened on March 27.

According to the MBA, the draft lays out the business requirements that should be met when dealing with electronic document formats like MISMO SMART Doc, eSigned PDF and Adobe Intelligent Document Format, as well as Microsoft Word that has embedded XML. The entire article can be found at:
