CONFER: Congress wants your water

There is an upcoming Congressional hearing about pending legislation known as the Clean Water Restoration Act of 2007. Bills HR2421 and S1870 are sponsored by Representative James Oberstar (D-MN) and Senator Russ Feingold (D-WI), respectively, and have significant cosponsorship right down the party line. This act, were it to be passed, would amend the language of the Clean Water Act of 1972.

The new version would delete the word "navigable" and replace it with the word "all." Therefore, no longer would federal jurisdiction apply only to lakes and rivers, but it would be extended to all bodies of water — permanent or intermittent — everywhere in the United States, be they in your backyard or on your farm. The federal definition will be extended to include, among other things, streams, wetlands, sloughs, wet meadows, and ponds. http://www.tonawanda-

Foreign experts will be allowed to take part in patent rights trials involving foreign parties, the Supreme People's Court (SPC) said Tuesday.

Intellectual property rights are becoming increasingly significant in China. Last year, the number of domestic patent applications rose to more than 301,000, up nearly 35 percent on 2006, while foreign applications grew almost 14 percent to more than 50,000, according to the State Intellectual Property Office (SIPO).

EU states urged to adopt



tougher copyright protection rules

The European Parliament urged member states to adopt newly drafted EU rules on copyright protection, introducing harmonised criminal sanctions across Europe for activities ranging from illegal downloading to the sale of counterfeit medicines.

The draft foresees the introduction of a number of measures to curb the violation of intellectual property rights, including custodial sentences, fines, destruction of fake goods, closure of estab-

lishments used to commit an offence, bans on engaging in commercial activities, or bans on access to public assistance or subsidies.
