Musgrave & RSC Chairwoman Myrick urge Chairman Young to look at other funding proposals

Washington DC: A strong proponent of highway construction, Rep. Marilyn Musgrave (CO-04), today, joined Republican Study Committee Chairwoman Sue Myrick in petitioning Transportation Chairman Don Young to hold full committee hearings to discuss transportation funding reforms.

Today, in a letter to Chairman Young, Musgrave and Myrick stressed that the recent introduction of the transportation re-authorization bill provides a suitable opportunity to investigate proposals that would generate billions of dollars for construction of highways, city streets, county roads, and bridges across the nation – without raising taxes. Funding for Young's bill reportedly relies heavily on his support for increasing the gas tax.

"Tragically, instead of seeking creative transportation reforms, it seems that some Members of Congress have resolved that raising taxes is the only way fund road construction," said Musgrave. "Instead of collecting more in taxes at the pump, I propose the federal government investigate and institute some responsible reforms."

Throughout this session in Congress, several alternative proposals to raising the federal gasoline tax have been offered by Members of the House and Senate, including the FAST Act, reforming the Davis - Bacon Act, bonding initiatives, and ending government siphoning of transportation funds for other purposes. In fact, Musgrave recently introduced H.R. 2672, a bill that focuses on the inefficiencies of construction and introduces a cost-saving alternative. This bill has the support of 60 bi-partisan cosponsors.

Securing funding for our nation's interstate highways, city streets, county roads and bridges should be one of the top priorities of the 108th Congress.
