DATE	BILL	DEMOCRATIC UNITY	DEMOCRATIC PRIORITIES
5/18/06	H. Con. Res. 376: House Republican Budget for FY 2007	100% (opposed)	Democrats voted for fiscal responsibility and against the misguided Republican budget plan that would add \$653 billion to the \$3 trillion added to the national debt by Republicans since 2001.
5/18/06	H. Con. Res. 376: Democratic (Spratt) Substitute to the FY 2007 Budget	94% (in favor)	Democrats voted for fiscal responsibility by supporting the Spratt alternative, which would reach balance in 2012. They also supported investing in America's priorities.
5/10/06	H.R. 4297: Tax Reconciliation Conference Report	92% (opposed)	Democrats voted for fiscal responsibility and against giving more tax cuts to the wealthiest few while heaping tens of billions of dollars in additional debt on our children.
5/3/06	H.R. 4975: So-Called Lobbying "Accountability and Transparency" Act	96% (opposed)	Democrats voted for real reform and against this weak reform bill, which Republicans advanced simply to provide themselves political cover for the November election.
4/5/06	H.R. 513: 527 So-Called "Reform" Act	96% (opposed)	Democrats voted against curtailing the 1 st Amendment rights of independent organizations and reducing participation in the electoral process.
12/19/05	H.R. 4241/S.1932: Budget Reconciliation Conference Report	100% (opposed)	Democrats voted for investing in America and against this misguided Republican budget plan that cut investment in important programs like student loans and Medicare by \$39 billion, while adding \$100 billion to the already record GOP deficit.

12/14/05	H.R.3010: FY06 Labor-H Appropriations Conference Report	100% (opposed)	Democrats voted to protect students, working families, and some of the most vulnerable Americans from draconian Republican spending cuts.
12/8/05	H.R.4297: Republican Budget Reconciliation Bill	95.5% (opposed)	Democrats voted to protect 17 million families from the AMT, which the Republican bill failed to do.
10/26/05	H.R.1461: Motion to Recommit with Instructions on the Federal Housing Finance Reform Act	100% (in favor)	Democrats voted to ensure the rights of non-profit groups to use their funds for non-partisan voter registration.
10/7/05	H.R.3893: So-Called "Gasoline for America's Security" Act	100% (opposed)	Democrats voted to strengthen consumer protection laws to combat price-gouging and market manipulation, and to provide relief from record-high energy costs, which the Republican bill failed to do.
6/24/05	H.R.3010: Democratic Motion to send the FY06 Labor-H Appropriations Bill back to Committee with the intent that \$1 billion in FY05 Veterans Health care be added	100% (in favor)	Democrats voted to close the dangerous funding gap for America's veterans, which was ignored by the White House and Congressional Republicans.
5/24/05	H.R.810: Stem Cell Research Enhancement Act	93% (in favor)	Democrats voted to expand federal funding of stem cell research.
4/21/05	H.R.6: Capps Motion to Strike – Energy Policy Act	93% (in favor)	Democrats voted to delete provisions from the Energy Bill which provided immunity for producers of MTBE, a known carcinogen that has been found to contaminate ground water supplies nationwide.
1/4/05	H.RES.5: Motion to Commit With Instructions on the Republican House Rules Package	100% (in favor)	Democrats voted to ensure a functioning, fair and bipartisan ethics process in the 109 th Congress.
